Course Description

A broad interdisciplinary course in the historical development of the United States and North America to 1877. Note: Assignments will focus on reading, writing, and analysis. Pre/co-requisite Eng. 1301 or 1302.

Student Learning Outcomes

1. Critical Thinking - Students will be able to analyze, evaluate, or solve problems when given a set of circumstances, data, texts, or art.
2. Communication - In written, oral, and/or visual communication, A&M-Commerce students will communicate in a manner appropriate to the audience and occasion, with an evident message and organizational structure.
3. Personal Responsibility - Students will understand and practice academic honesty.
4. Social Responsibility - Students will demonstrate an understanding of societal and/or civic issues.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Use of a web-browser to access the internet. Use of a word processor such as Microsoft Word to create documents.

Instructional Methods

This will be an online readings course. The readings (including two videos) will provide all the evidence you need for creating evidence-based answers to the essay questions, as well as for answering the short ID & multiple choice questions.

Student Responsibilities or Tips for Success in the Course

You will need to complete all the readings in a timely manner. You must complete all work by the established due dates. This is a fully asynchronous course. You will begin by reading the assigned material listed in each section. Every assignment has a due date by which it must be completed

To be successful in this course, the written assessments are critical. You will find everything you need to address the written assignments in the readings/videos for this course. Expect to spend 30 or more hours reading/listening (depending on your reading speed). You should NOT use outside source material, not everything you find may be factual, reliable, and peer-reviewed. If you choose to use a quote, it should be short, no more than 2 lines. You must cite your sources. You may use any standard citation format you choose: APA, MLA, Chicago, or Turabian. If you are unfamiliar with any of these please utilize the University's Writing Center (<https://www.tamuc.edu/writing-center/>).

Final grades in this course will be based on the following scale:

Multiple Choice Quizzes: There are 4 multiple choice quizzes. Quiz due dates are listed on the calendar below. There are three reading quizzes that cover the text & supplemental readings and an Academic Honesty-Student Responsibility Quiz. The Responsibility quiz can be taken multiple times, but the other quizzes may only be attempted one time, and automatically end if you leave the quiz without finishing.

Adobe Assignment: You will choose one event from this period of U.S. history to explain using the tools in Adobe Creative Cloud. An additional assignment explanation document will be available in D2L.

Short IDs: There are 3 Short ID assignments, each with 1 short ID prompt. The short identification questions require a written response, using complete sentences and appropriate grammar and punctuation. It should be one to two paragraphs in length. It

should include the Who, What, Where, When, How, Why of the item in the prompt, as well as an explanation of its significance. Significance is the explanation of why it is worth knowing about, how it enhances our understanding of the past. You will be expected to cite any quotes you use (see Student Responsibilities and Tips above). You should only use sources assigned for this class.

Essays: You must be able to write a coherent, well-structured essay that adequately addresses the question. Essays require a long-form written response, using complete sentences and appropriate grammar and punctuation. Expect to write 500 to 750 words to fully answer the prompt. You will be expected to cite any sources and quotes you use (see Student Responsibilities and Tips above), and to cite at least three reliable sources. **You should only use sources assigned for this class.** There are 2 Essay assignments. Each will be scored on a 25 point scale and the lower grade will be dropped.

Academic Honesty and Dishonesty

You are expected to do your own work. Dishonesty will not be treated lightly. On each graded assignment I expect each student to honor the following pledge: “I hereby give my word that I have neither given nor received aid while completing this assignment.” Any student found violating this policy will receive a grade of zero for the assignment, and further action may be taken. Two instances of academic dishonesty will result in an immediate F for the course.

Plagiarism:

Plagiarism is taking someone else’s work and passing it off as your own words, thoughts, or ideas. This includes, but is not limited to, using direct quotes out of a book or from the internet as your own words, properly using quotation marks but noting the wrong person as the author, purchasing a paper or exam from friends or strangers, using material from the internet verbatim as your own words, and cutting and pasting entire papers or internet pages and passing it off as your own work. Cheating on exams and discussion posts or allowing others to copy your answers is another form of academic dishonesty.

It may be acceptable to use other people’s words as short quotations and ideas as long as they receive credit in citations. If you are unsure about the precise definition of plagiarism and/or think you may have committed this form of academic dishonesty, see the instructor or visit the Online Writing Lab before you turn in the assignment.
