Course Description and Student Learning Outcomes:

Honors colloquia are scheduled weekly to provide Honors students the opportunity to discuss timely local, regional, and world issues as well as other enlightening topics with faculty, administrators, community leaders, and other honors students. The Honors colloquium is informal as well as educational. The overall goals are to provide opportunities to be motivated by others' enthusiasm for their field, to be exposed to new ideas, and to share time with other intellectually-curious students.

COURSE REQUIREMENTS

Instructional Methods, Activities, and Assessments

A. Attendance

You are allowed ONE absence this semester. If you accumulate more than one absence, you will not receive credit for the class. Further, once here, please treat our speakers with the attention and courtesy that they deserve. **Please turn off all cell phones and do not engage in texting while in class.** During discussion weeks, students are expected to participate actively in what should be lively discussions and debates. Of course, all students enrolled at the university shall follow the tenets of common decency and acceptable behavior conducive to a positive learning environment (see current Student's Guidebook).

I do want to throw out one caveat as we continue to work through a time of serious respiratory illnesses. You should not attend class when you might be ill. (Remember, COVID and flu testing are free at the Student Health Center across the street from where you live.) Speak with me if illness would lead to a second absence.

B. <u>Reaction Papers</u>:

To gain credit for HC 400, students are required to write reaction papers on TWO presentations. I have set incremental due dates for the TWO papers, and students who miss a deadline will be

allowed to submit a late paper for partial credit depending on the quality of the paper. Please be mindful of the deadlines to avoid a mistake and a reduction in grade. Additionally, students who do not submit BOTH papers on time CANNOT earn an A in the course, although simply submitting papers on time does not guarantee a grade of "A." Rather, a student must be sure to write a proper reaction paper that contains an intellectual reflection on what took place during the colloquia. That reflection in writing should go beyond being merely a series of notes you take and write up.

The paper may cover some of the following points:

- What was said that you agreed with?
- > Or disagreed with?
- Can you connect an aspect of what you learned from the colloquium session to another event you have read about or heard about or observed or even experienced in your own life?
- What interested you the most?
- Least?
- > What would you have done or said differently?

Obviously, you do not have to answer all of the above questions, nor do you have to respond to any one of them. What your paper should show is your mind at work—much like a book critic or movie critic does when she or he writes a review. For length, shoot for a minimum of two double-spaced pages of type.

Please submit your papers through the D2L portal.

C. <u>Class Discussion</u>

We will periodically have class discussions to debrief at regular intervals during our course. These sessions provide the opportunity to collectively share our reactions and discuss the topics raised by our speakers. Students are expected to attend these class periods and become active members of the conversation.

D. Letter to Freshman Assignment

Each colloquium speaker will highlight their own individual expertise and often draw upon life lessons that may be applicable to your own experiences. As you near the end of your college career, you have grown and developed an acumen for success. Pen a letter to an incoming freshman. What lessons have you learned during your time in the Honors College? At TAMU-C? In life? What advice would you give a brand new college freshman so they can maximize their college experience?
