# **COURSE INFORMATION**

Additional required readings will be assigned weekly in D2L/Brightspace and resources will be provided in the online learning platform in order to access the readings.

# **Course Description**

American crime problems are studied in the historical perspective. Social and public policy factors affecting crime are discussed. The impact of crime and crime trends are shown along with the social characteristics of specific crimes. The prevention of crime is emphasized.

**Student Learning Outcomes:** Upon successful completion of this course, students should be able to do the following:

- 1. Describe and evaluate major theoretical explanations of crime.
- 2. Explain the extent, variety, locations, and impact of crime and delinquency in America.
- 3. Identify key criminogenic conditions.
- 4. Describe and evaluate our systems for recording and measuring crime.
- 5. Evaluate the effectiveness of social policies related to crime control.
- 6. Enumerate and explain the major factors which mitigate to lessen criminal responsibility.
- 7. Critique key characteristics of major criminology theory groups.
- 8. Discuss key features of major crime typologies.

## **COURSE REQUIREMENTS**

#### **Minimal Technical Skills Needed**

Using the learning management system (D2L), using Microsoft Word and PowerPoint, using presentation and graphics programs, and Turnitin. Written and oral communication skills; reading; memorization; critical thinking. You should know how to access a Web site when given an address, use the features of your Web browser, download files, attach files to emails, and use word processing software, ...etc.

#### **Instructional Methods**

This course is designed in a format that is delivered asynchronously 100% online. In the online environment, students will be engaged in discussion forums and weekly unit completion of materials that will lend success to completion of the course work. The weekly lessons will be released on Sunday at 5pm.

Each week/unit starts on Monday and ends on Sunday at 11:59pm CST and your grade for activities will be posted as soon thereafter as possible. See due dates for specific assignments posted in MyLeo/D2L.

This course will provide a variety of activities and assessments to assist you in achieving the outcomes/objectives for the course. You will work toward achieving these outcomes through discussions/comments, written assignments, video assignments, quizzes and exams.

## Student Responsibilities or Tips for Success in the Course

The student must log into the course through myLeo multiple times throughout the week to complete weekly assignments and post and respond on discussion boards. Weekly reading is expected as well as taking scheduled quizzes/exams and completing all other assignments. Students should check email daily and set up automatic notifications for announcements and other reminders in the D2L system. Any changes/updates to assignments will be posted mainly through the "Announcements" tool on D2L.

Students must cite in-text using APA style for all assignments. All written work is subject to Turnitin review. Any student who plagiarizes will receive a zero on the assignment in question.

#### Assessments

#### Exams

There will be four exams in the course worth 100 points each (400 total course points). They will cover assigned chapters/readings for that section and the due dates will be posted in the course calendar. Exams will consist of essay, multiple choice and true/false questions. Essays require essay format and at least two paragraphs of content. You will have 2 hours in which to take the exam. You may take the exam one time.

Historical Crime and Integrated Theory Presentation or Paper: (150 points total – 10 points for Proposal and 140 points for presentation or paper). Proposal is due 3/26/23 by 11:59pm and Presentation or Paper is due 4/30/23 by 11:59pm. See MyLeo/D2L Assignment for details and Rubric.

**Participation/Discussions:** (10 posts/comments at 40 points each = 400 points) There will be 10 discussions posted throughout the semester worth 40 points each total (30 points for the initial post and 10 points for your comments). Discussion on topics must be done during the week(s) we are discussing the course material. Posts are due on Saturday by 11:59pm and comments are due by Sunday at 11:59pm of the week assigned.

Introduction (1 Introduction post not graded) Every student must introduce him- or herself by the fifth day of class (Saturday) during Week One. This information will be entered as a threaded discussion. You will receive 10 extra credit points for completing this task by the deadline. See introduction assignment post details in D2L.

#### **Discussion Posts**

The Discussions in this class will focus on the specific assignments connected to each week. Each student is expected to participate in the weekly discussion by responding to ideas(s) presented by the professor. A minimum of one initial discussion per week is required by Saturday at 11:59pm of the week assigned and two peer responses by Sunday. This must not be all on one day. Students may post earlier than the absolute due date if desired, but no later than the identified date. Five (5) points will be deducted for posts made after the Saturday deadline. The post will close on Sunday of the week assigned. Posts cannot be entered once the discussion is closed (Sunday at 1:59 pm).

The **Discussions** are directly related to the assigned lecture material. Upon completion of the assigned lecture material, you are expected to engage in an **ongoing** discussion/debate with your classmates. Your contributions to the discussion forums will be graded for **quality** and a **detailed analysis** linking the material to a critical appraisal of theory, policy, and practice. You must integrate course material (textbook) and outside material into your post and cite it properly. In all cases, students must have **one in-text citation and provide a full bibliography/works cited at the end of their post for all citations mentioned in the post in APA format** (See information later in the syllabus for more information on citing utilizing APA citation format).

These posts should be **the equivalent of 1 page in length or a minimum of 250 words**. The specific discussion assignment is located in each unit Week by clicking on the Discussion link.

Posts are due by Saturday at 11:59PM CST during the week assigned.

#### **Comment Posts**

Comment posts are responses you make to the discussion posts that you and your classmates post each week and are due by Sunday by 11:59pm. You are **required** to

make a minimum of **two** comments for each discussion. I would strongly encourage you to engage your colleagues well past the two-comment minimum in order to maximize your opportunity for meaningful discussion and learning.

Comment posts should be meaningful, and at least one paragraph in length. Merely agreeing or disagreeing with a classmate will not be looked upon favorably and will result in a loss of points. A meaningful post is one that moves the discussion forward in some substantive way through providing one's perspective, additional information through research, or reframing the discussion in some new way. You are expected to engage in an **ongoing** discussion/debate with your classmates. Your comments will be graded for **quality**, and **relevance**. Your comments will also be graded based on your ability to engage in critical thinking.

**NO LATE COMMENTS ARE ACCEPTED**. All comment posts are due by Sunday at 11:59PM of the week assigned.

**Assessment Method**: Comments and the Discussion Post will be graded using the Discussion/Comments Grading Rubric. See information in D2L/Brightspace for Discussion Rubric. The discussion and comments for each week will be graded together and posted as one grade (Discussion = (30) + Comments 2 @ 5 points each (10) = 40 points).

#### <u> Notes Journal – 50 points</u>

The purpose of the Notes Journal is to document your gained knowledge and reflections of the course materials. The Notes Journal can be used for all your assignments in the course and ideally be helpful for your future courses.

Your Notes Journal can take any form that works for you. It can be typed, handwritten, stored on a website/blog, audio or video-recorded, etc. You will ultimately have to submit it electronically in some way so I can grade it. If your Notes Journal is digital, you can upload the document, website URL, etc. If you have a paper journal, you can scan it and then upload it.

I ask that you complete at least one journal entry per week that a reading is assigned to reflect on that week's readings, but you may also write on anything you like. Your Notes Journal can contain your answers to review questions, notes from discussions and activities, copies of the articles/websites you have read in the course, any questions you have, connections you're making between topics, a summary of the major points, your thoughts and reflections on the course material, etc. There may be points of time in the semester that I will pose a specific question to be addressed in the notes journal and will look for responses to the specific question posed. Everything I read will be kept confidential.

This assignment will be graded based largely on completion and insight not necessarily length. There will be two deadlines for the Notes Journal – the end of Week #8 (3/12/23) and the end of Week #15 (5/6/23). The Notes Journal is worth 50 points.

#### Notes Journal Late Submission Policy

Your grade will be lowered by 10% for each day late unless you have contacted me beforehand to explain any circumstances and we have agreed to an extension **before the due date**. Late Notes Journals will not be accepted after three days.

## **APA Citation Format Policy**

It is very important that you learn how to cite properly. In some ways, citations are more important than the actual text of your paper/assignment. Therefore, you should take this task seriously and devote some time to understanding how to cite properly. If you take the time to understand this process up front, it will save you a significant amount of time in the long run (not to mention significant deductions in points).

In the social and behavioral sciences (including Criminal Justice), we use APA (American Psychological Association) format. As a rule of thumb, one cites whenever they are paraphrasing other people's words or when they quote other's words directly. You may learn to cite from a variety of different sources including the APA Tutorial and the sources listed below.

### Late Work

My position is that everyone knows the rules of engagement at the beginning of the term and that it is the student's responsibility to ensure that they plan accordingly to submit their assignments in a timely manner. However, I do note that life circumstances arise. Therefore – the Historical Crime and Integrated Theory Assignment will receive a

20% deduction in points if submitted after the due date and cannot be accepted beyond one week of the due date late unless you have contacted me beforehand to explain any circumstances and we have agreed to an extension **before the due date**. Late comments on discussions will not be accepted. When a discussion is closed it cannot be reopened for late submissions. Quizzes cannot be made up. Exams will only be allowed a late submission under extenuating, documented circumstances. Written assignments and discussions cannot be regraded or redone.
