

Consequently, this course will depend on you to **complete all assigned readings** and be prepared to discuss them in online class in a timely manner. Please note that all assigned readings are critically important for successfully completing exams and class activities.

Please note the following important items:

- 1. This syllabus is subject to change at any time at the professor's discretion.
- 2. The classroom portion of this course requires 100% attendance, extensive readings ON A DAILY BASIS, and full participation. You have carefully read the assigned material before class.
- 3. The places we will visit may be of a highly sensitive nature. Students are required to display maturity and respect for each other, program staff, and the traditions of our host country at all times. Once we are in Korea, we are bound by all Korean laws.
- 4. Failure to comply with all faculty instructions while abroad, failure to comply with any aspects of this syllabus, the Code of Student Conduct and the Student Handbook, failure to treat all of your fellow participants, staff, and the host country with maturity, courtesy and respect, engaging in ANY activity that is illegal in Korea, engaging in any activity that hinders your full participation in all program activities, and/or engaging in any activity that may bring disrepute to Texas A&M University-Commerce, the Global Programs Office, or yourself, may result in your IMMEDIATE DISMISSAL from the program, a grade of "F" in this course, YOUR IMMEDIATE DEPARTURE FROM Korea AT YOUR OWN EXPENSE,

and/or a review by an appropriate university disciplinary agency and/or any law enforcement agency.

Course Description

The purpose of this course is to improve the understanding of politics and economy in Korea. Students are expected to enhance their knowledge about democracy, democratic consolidation, South Korea-US relations, and two Koreas and theories and practices of economic development in Korea.

Student Learning Outcomes

Upon completion of this course

- 1. Students will be able to understand the political dynamics of democratic transformation in Korea.
- 2. Students will be able to assess the institutional context of economic development found in Korea.
- 3. Students will be able to recognize critical political and policy issues in Korea.

Course Policies and Procedures

All students are expected to comply with the following requirements.

Classroom Civility

Students are expected to assist in maintaining a classroom environment which is conducive to learning. In order to assure that all students have an opportunity to gain from time spent in class, unless otherwise approved by the instructor, students are prohibited from using electronic devices, challenging instructor's authority, eating or drinking in class, coming in late or leaving early, making offensive remarks, reading newspapers, sleeping or engaging in any other form of distraction. Inappropriate behavior in the classroom shall result in, minimally, a request to leave class. No student will be allowed to "dominate" any class period.

Also tape recorders, camera and video phones, and all other visual and auditory recording or retention devices, are strictly prohibited in this class. Please do not bring or use those devices.

Plagiarism

<u>Plagiarism is a serious offense and will not be tolerated</u>. Plagiarism occurs when a student purposefully or unintentionally takes information directly from a source without proper citation. For example, forgetting to cite an author and page number with a quote is plagiarism, as is direct copying and pasting from a website. Plagiarism will result in an F for the course and notification to the university. Plagiarism is often a result of improper citation and/or acknowledgement of sources; therefore, we will be going over plagiarism in class so you can avoid common pitfalls (and an F!). If a student needs additional assistance, please consult me during my office hours.

Readings Presentation

Each student will be assigned to present readings and help lead the discussions throughout the classroom portion of the course on a rotating basis. These presentations must be posted on D2L by 9 AM, May 12. Each presentation will be *limited to 30 minutes*. Your presentations are collectively worth **30%** of your grade.

Attendance and Participation

Positive participation in the classroom includes:

- attending ALL classroom sessions
- being an active participant in class
- responding to your instructor's questions
- asking your own questions
- contributing to class discussions

Your participation grade will be reduced if you sleep in class, use personal electronic devices in class, misbehave in class, or disrupt class in any way.

Positive participation in required study abroad activities includes:

- -ABOVE ALL- BEING FLEXIBLE AND DEMONSTRATING A POSITIVE ATTITUDE -particularly when faced with adverse and/or unexpected circumstances;
- notifying your professor or graduate assistant IMMEDIATELY in the event of any strange, emergency, or potential emergency situations;
- NOT COMPLAINING (without a well-substantiated cause);
- being ON TIME;
- correctly FOLLOWING INSTRUCTIONS;

- and fully participating in ALL required activities (activities that are considered "optional" are not required- you will be informed whether a given activity is optional or required).

Attendance and participation is worth **30%** of your grade. Any absences, tardiness, negative behavior, and/or unsubstantiated/unwarranted negativity will result in a significant reduction of your attendance and participation grade. You will be informed which activities are required and which are optional by your professor. In severe cases of absences or other negative behavior, YOU MAY BE REQUIRED TO LEAVE THE STUDY ABROAD PROGRAM AT YOUR OWN EXPENSE.

Reflection Paper

A major portion of this class will be the completion of a reflectoin paper. This reflectoin paper requires students to analyze a critical political or economic issue in Korea. A research paper should be **3-4 pages** in length. A good paper will include an introduction, a thesis statement, and a conclusion. A handout with details on the research paper will be distributed later. Research paper is worth **30%** of your grade.

Journal

ALL Students will also be required to keep a daily journal of activities from **May 16-May 26**. This will consist of **at least one handwritten page per day** in a traditional spiral notebook (wide ruled) or the equivalent. The journal is worth **10%** of your grade.
