Course Description

The purpose of this course is to facilitate the learning of talent development practices in the real world. This course investigates the theoretical foundations of specific talent development practices with a special emphasis on the ways in which these practices are represented in films. The focus will be on people analytics, mentoring, and career development which has significant

implications for workplace learning, performance improvement, employee engagement, and a host of related topics.

- Analyze and interpret talent development practices based on the concepts of talent development
- Apply theoretical foundations of talent development to solve talent development issues in the workplace.

Course Grade

Weekly discussion (3 at 100 points each): Online discussions will serve as a comprehension check on selected topics. When you post your original message and respond to the work of others, always see if it adds substance/meaning to the topic. You need to say why and you can provide examples, experiences, resources, alternative perspectives, challenging views, etc, to make the dialogue richer.

Copying and pasting, along with attaching/uploading documents for assignment submission, will also be required.
