### <u>University Course Catalogue Description</u>

This course addresses how to develop and organize effective oral presentations. This class covers theories and related skills for planning, organizing, rehearsing, presenting and evaluating different types of speeches as well as rhetorical traditions, principles, and strategies used in informative, persuasive, and ceremonial speeches. Emphasis on student performance and evaluation of oral and written models of classical and contemporary speeches. Recommended for students pursuing careers in sales, human resources, training and development, teaching, law, the ministry, politics, or other professions requiring public presentations. May be taken to meet a communication requirement.

## Student Learning Outcomes:

This course explores theory and principles of effective public speaking while providing an emphasis on skills development. Specific attention is given to the preparation, delivery, and evaluation of public speeches. General student learning outcomes include the following:

- 1. Students will understand theory and practice in public speaking.
- 2. Students will learn and develop various fundamentals and tools of effective speech delivery.
- 3. Students will be able to critically analyze the content, organization, and delivery of their own speeches

and the speeches of others.

- 4. Students will become competent and confident public speakers.
- 5. Students will synergize theories and principles of communication into the successful preparation and delivery.
- 6. Students will be able to analyze, evaluate, or solve problems when given a set of circumstances, data, texts, or art.
- 7. In written, oral, and/or visual communication, A&M-Commerce students will communicate in a manner appropriate to audience and occasion, with an evident message and organizational structure.
- 8. Students will understand and practice academic honesty.
- 9. Students will demonstrate an understanding of societal and/or civic issues.

Test questions will come from the assigned chapters as well as any notes sent out. Students must take the tests without any assistance from other people. They may use their textbooks but the tests will be timed. Academic integrity is described in the student handbook for Texas A&M University-Commerce. Failure to abide by the rules outline may result in failing the class. If a week has both a test and discussion in that week, the discussion will not be part of that test but will be covered on the next test. Due to multiple sections of this class taking similar tests, test answers will not be given after the test as to correct and incorrect answers. The students' scores will be the feedback that they receive concerning their test performance. Students preparing for tests should study how concepts are related to each other, how they differ, and come up with personal examples of the concepts. The test questions are usually not straight forward definitions but often give an example and ask the student which concept the example best represents.

### Discussion- (10%)

All discussions are finished by the Friday of the week they are assigned at 5:00 PM Central Time. A list of questions is given at the end of the syllabus for each section. The first student to post a comment or question for a section should consider addressing one of these questions. Students are required to post 2 questions and respond to 2 other questions that are posted each week. Students need to come up with their own original questions to post and not re-post previous questions from other students or the syllabus. Likewise, students need to refrain from answering the same questions other students previously fully answered. Some repetition is acceptable if it helps to develop the ideas and concepts. The objective is to expand and apply the course material. Students cannot post questions or comments for any section except the present one. Hence, you need to stay on top of your participation for each section. It is helpful for viewing in DL2 Brightspace if students begin a new post with each of their original questions they post rather than connected to a previous comment or posting more than one question together.

#### Nonverbal Delivery Paper: 10% Overall Grade

Nonverbal communication behaviors play an important role during presentations. The purpose of this paper is to improve your nonverbal communication delivery skills.

Furlich (2022) has several chapters addressing nonverbal communication when delivering a presentation. First, summarize the information from the assigned chapters. Secondly, describe how you can specifically use this information to improve your nonverbal communication delivery. You must use at least **5 different concepts (ideas, terms)** from Furlich (2022) addressing these areas. Clearly indicate the concepts (ideas, terms) used by <u>underlining</u> them. Some chapters from Furlich (2022) to address are Ch. 7, 8, 12, 13. Feel free to use more. The paper should be 1-2 pages double-spaced with one-inch margins. Submit the paper electronically in the properly labeled folder in the course.

Please submit the paper through Course Shell, Content, Assignments for this class in then the appropriate file labeled nonverbal delivery paper.

\*Please only submit written assignments as attachments in WORD in Content, Assignments, Proper Envelop. Other files such as PDF files are too difficult to grade.

\*Note: All speeches must be video recorded so that the speaker can be seen delivering their speech along with sound. Audio recorded only speeches will not be accepted. If the first electronic means of saving does not work FOR THE INSTRUCTOR TO VIEW, then students must try other formats. Students refusing to try these other formats will not receive a grade for that speech.

\*Note: Students must first state their name and date before beginning their speech. Students must stand up to deliver their entire speech.

ALL SPEECHES MUST BE PAPERLESS. THIS MEANS NO PAPERS HELD DURING THE PRESENTATION. STUDENTS CAN HAVE THEIR OUTLINE FLAT ON A DESK TO ELABORATE FROM DURING THEIR PRESENTATION. NO READING SPEECHES. Presentation 1: Each student will deliver an informative speech of 4:30-5:30 minutes. Each student must state their name and date before beginning and stand for the entire presentation and show at least half of themselves. Students are not allowed to wear a hat or chew gum. Presentations that are too low in volume to hear will not be graded and can result in a 0%. Each student must state their name and class before beginning their presentation. Please play your speech before submitting it to check the volume. The purpose is to inform the audience and not persuade them. The presentation will consist of gathering at least 3 credible outside sources for your presentation and using a Visual Aid. Internet web-site sources, Wikipedia, Dictionary, Class Book will not count as part of the required 3 sources. Using books and journal articles are encouraged to be cited during your presentation. Each student will turn in an outline and a reference page of sources in Content, Assignments, Appropriate folder. Points will be deducted for not abiding to the time limit. Each student will

submit their video presentation in Content, Assignments, then the appropriate file folder. It can be submitted in a WORD document with your speech link (such as uploaded on youtube.com) on the WORD file on top clearly labeled. \*It is helpful if all three requirements are on the same WORD file (Outline, Reference page, Speech link) with only one file submitted per student. Attachments of the presentation can also be sent as an email attachment.

Presentation 2: Each student will deliver a persuasive speech of 4:30-5:30 minutes. Each student must state their name and date before beginning and stand for the entire presentation and show at least half of themselves. Students are not allowed to wear a hat or chew gum. Presentations that are too low in volume to hear will not be graded and can result in a 0%. Each student must state their name and class before beginning their presentation. Please play your speech before submitting it to check the volume. The purpose is to persuade the audience to accept the speaker's ideas about a particular issue. It is imperative for the speaker to demonstrate why his or her side of an issue is superior to the opposing one. The presentation will consist of gathering at least 3 credible outside sources in Content, Assignments, Appropriate folder for your presentation. Internet web-site, Wikipedia, Dictionary, Class book, sources will not count as part of the required 3 sources. Using books and journal articles are encouraged to be cited during your presentation. A visual aid is also required for the presentation. Each student will turn in an **outline and a reference page** of sources in Content, Assignments, Appropriate Folder. Each student will submit their video presentation in Content, Assignments, then the appropriate file folder. It can be submitted in a WORD document with your speech link (such as uploaded on youtube.com) on the WORD file. \*It is helpful if all three requirements are on the same WORD file (Outline, Reference page, Speech link) with only one file submitted per student. Attachments of the presentation can be sent as an email attachment.

Be sure topics are appropriate for the class. Points will be deducted for not abiding to the time limit. A list of Unacceptable speech topics is in Dl2 Bright Space Course Shell.

#### \* Course Behaviors

Students may lose 10% of their final grade or be dropped from the class for acting disrespectful the first time. This includes but is not limited to offensive comments to another student, etc. Students can receive an 'F' in the class for academic dishonesty. This includes but is not limited to cheating on tests, using previous work from another class for assignments, copying another's work from anywhere, etc.

### **Course Procedures**

<u>Assignments</u> - Assignments must be completed on time. Late work will result in loss of points. Academic integrity is expected on all course assignments and activities. <u>Make-Up Assignments and Examinations</u> - If you miss an exam or paper submission deadline it must be for one of the following types of documentable reasons: death in the family, severe personal illness, university sponsored activities, etc. If you have an unexcused absence on a day you are scheduled to make a presentation or take a test, you <u>cannot</u> make up that presentation or test. Additionally, because of time constraints, the instructor may elect <u>not</u> to grant make-up speeches for any reason. In order to take a make-up examination you must submit verifiable and official documentation to your instructor (e.g., a

doctor's note for the specific day missed). If your request is approved, you may take a make-up test on the appointed day. All make-up exams must be given for qualified persons within 2 weeks of the missed test.

Observance of a Religious Holy Day – Texas House Bill 256 requires institutions of higher education to excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day. ### **Discussion Questions**

**Week 1:** Are there any jobs that communication is not present or required? What are some similarities and differences between giving a speech and having a conversation? What does it mean that communication takes place within a system? Why is audience analysis important? How to use audience analysis?

Week 2: (Test 1, Speech 1 Due Friday). Why is speech anxiety popular? How much can speech anxiety change versus biological factors? What are some interviewing tips covered in the notes that most people are not aware of? What are some

similarities and differences between the beginning of studying public speaking and today? What are some general themes to consider when determining the truthfulness of someone?

What are some delivery techniques covered in the notes that most people are unaware of?

How can a group be used more effectively than the individuals working separately?

Week 5: (Test 3). How do different presentation formats change the way a particular presentation is created and delivered? What are some environmental factors that impact communication? How can one change the environment to meet their particular communication goals?
