## **Course Description**

A broad interdisciplinary course in the historical development of the United States and North America from 1865. Note: Assignments will focus on reading, writing, and analysis. Prerequisites: ENG 1301 or concurrent enrollment or ENG 1302 or concurrent enrollment.

# Instructor's Description:

A survey of US history from 1865 to the present. This course interrogates US social, political, and economic history while placing particular attention on themes like identity, agency, and power.

### **Student Learning Outcomes**

- 1. Students will be able to form substantive and evidence-driven arguments to propose solutions to problems or explain phenomena.
- 2. Student communication will follow conventions of grammar and syntax appropriate to the audience, purpose, and message.
- 3. Students will demonstrate awareness of the societal and/or civic issues.
- 4. Students will be able to understand their role in their own education.

# **Course Requirements**

#### **Instructional Methods**

Course material will be delivered through a variety of modes including, but not limited to, readings, primary and secondary source analysis, online group discussions, and exams. The course will be managed through the university's D2L system, through which students can access relevant information such as primary source documents, discussion boards, and announcements. Students are responsible for checking D2L periodically to access course assignments and potential changes to the syllabus.

# **Classroom Expectations**

# **Assignments and Exams:**

Every effort will be made to have assignments and exams graded within 10 days after the due date, except for the Final Exam. This allows time for careful grading of all assignments.

## **Academic Honesty Quiz: 5%**

The academic honesty quiz will be made available to all students on D2L. It provides information on academic honesty and the potential consequences for violating these policies.

#### **Primary Source Post/Responses: 25% total**

Students are responsible for contributing to FIVE discussions. Each initial post must be at least 300 words in length and must directly address the question(s) posed. Each student must respond to TWO posts from peers/classmates for each discussion board. Peer responses must be at least three sentences in length. Begin your peer response by acknowledging by name the person to whom you are responding. For example, "John, I like what you said about...." Your response cannot be vague. Be specific about what resonated with you in your peer's post. Each student will have a total of 15 posts/responses over the course of the semester. You can find the discussion forum on D2L module.

## **Primary Source Analysis: 15%**

Students will examine two primary source documents to analyze a historical event, narrative, theme, etc. By examining two documents, this assignment provides an opportunity to consider a theme, event, or narrative through diverse perspectives.

## **Adobe Project: 15%**

The Adobe project will highlight themes of class, race, and gender as they relate to US history. A specific theme and time scope will be determined within the first week of class and be communicated to the

students. As this assignment is completed, it will allow students to collaborate and gain a broader understanding of themes covered in this course.

#### Mid-Term and Final Exams: 20% each

There will be two exams during the semester including the final exam at the end of the semester. The format of the exams will be a combination of multiple-choice, identifications and written responses. The final exam will not be comprehensive.

#### **Interaction with Instructor Statement**

Students should feel free to contact me directly via e-mail (see above) if they have questions about anything related to the course. E-mails should include a greeting ("Good morning, Professor...") and a closing ("Sincerely, [your name]). I will extend the same e-mail etiquette to you and will do my best to respond to e-mails in a timely manner. Also, either on the subject line or within the email, note what class you are enrolled in.

I will hold online office hours once a week (see above) during which students can log on to talk about assignments, course content, grades, or anything else related to the course. You do not need an appointment during this time.
