Course Description:

This course is designed to increase awareness and understanding of critical issues surrounding the evolving concept of literacy. This course will study selected issues affecting educational thought and schooling practices emphasizing critical analysis of the cultural, political, and sociological contexts of school-societal problems.

Objectives

Student Learning Outcomes (SLO):

1. To read, assess, and internalize the various interrelated components of reading and in reading instruction at the primary, intermediate/middle, or high school level.
2. Apply and share the knowledge gained as they become or continue to be literacy leaders, impact of the literacy program on students based on cultural factors, political factors, and sociological factors.
3. Articulate their analysis of readings through grand discussions postings via D2L discussions.

COURSE REQUIREMENTS

Instructional / Methods / Activities Assessments:

A. Expectations: Students in this course are exposed to critical issues surrounding the evolving concept of literacy. This course will study selected issues affecting educational thought and schooling practices emphasizing analysis of the cultural, political, and sociological contexts of school-societal problems, diverse perspectives in the context of literacy assessments that will stretch your thoughts and perceptions beyond your present experiences and knowledge.

B. Assignments

1. **Module Chapter Journal Entries:** (25 points each): In Modules 1-4 you will reflectively respond to prompts based on chapter readings regarding various critical literacy issues. (SLO 1, 2)
2. **Module Threaded Discussion:** (100 points): In Module 1 you will be asked to respond to topic with talking points. (SLO 2, 3) They can be in the form of salient points, questions, points of disagreement, applications to teaching, or anything else you think is important. You will submit your talking points as well as share them on the discussion board.
3. **Exploring Media Literacy Assignment (Part I & Part II -100 points):** In Module 2 you will explore critical and media literacy. You will analyze various media sources using media literacy principles and create a media literacy learning experience for students.
4. **Critical Issue Multimodal Project (CIMP)** (60 points) (SLO 1, 2)

In this culminating project, you will research and present a critical literacy issue and recommendations digitally in a self-selected style. Components of the project must represent multi modalities. The project includes a narrated presentation, annotated bibliography, stakeholder letter, and a review of at least one classmate's Critical Issue Multimodal Project.

- *saved on computer disk or copied on paper for your records
