# **Course Description**

The study of the importance of others' influence on one's attitudes, perceptions, motivations, and behavior, the dynamic fragility and power of group participation, and the extent to which human potential is enhanced or severely limited in the context of group life.

- Explain the sociological perspective on social psychology
- Describe and assess the basic social psychological theories, principles, and concepts explaining social cognition, attitude formation, decision making, group processes, prosocial behavior, aggression, conformity/obedience, and stereotyping/prejudice

• Relate knowledge of theory as well as current and past research in social psychology to situations in everyday life such as interpersonal and group relations
