In-Person:

Other optional light sources such as lamps, flood lights, florescent light bars, and LED bars can also be useful. I will send you gel to color the light sources with. So you will need to send me your address so I can send you supplies.

Pieces of fabric, rocks, sticks, figurines, and the like that you can light. Random objects with a variety of textures.

Course Description

THE 545, Stage Lighting, is a graduate level course that will provide the student with the fundamental knowledge and basic techniques of stage lighting. A variety of lighting styles are covered, and students will be required to recreate the lighting looks that they have been shown. This course is presented in both a lecture format as well as practical application of the material presented.

Student Learning Outcomes:

- 1. Students will learn the fundamentals and basic skills techniques of a variety of stage lighting styles.
- 2. Students will be able to create/design basic stage lighting scenarios and looks.
- 3. Students will understand the purpose and use of technical paperwork and research development as it pertains to stage lighting.

This class will utilize a combination of quizzes and practical assignments. Access to d2l and document writing/slide making programs is needed.

This course will be taught in person utilizing d2l
