ASSESSMENT

Book Summary/Review: 20% Students are required to read the assigned book and write a book summary/review. Must be submitted as an MS Word file. Please see D2L for more details.

Assignments: 39% There will be three writing assignments each worth 13% of your grade. Must be submitted as an MS Word file. Please see D2L for more details.

Discussion Board: 36% Articles (7% each) and the book (15%) will have multiple discussion topics that you will be required to participate in. Discussion board topics require a minimum of one post and **three replies** to fellow students. Discussions may be completed and submitted prior to the posted due date, but keep in mind that you will be graded on quality of content. Spelling, punctuation, capitalization, and grammar errors will have a negative impact on your discussion grades.

Syllabus and Calendar Quiz: 5% Students will be required to take one quiz covering material found in the syllabus, calendar, and grading rubrics.

IMPORTANT: Assignments may be submitted early, but I will count off one letter grade for each day an assignment is late. Exams, quizzes, and discussions will not be opened after the due date. No extra credit work will be assigned under any circumstances. The following are the <u>ONLY</u> acceptable excuses for missed assignments. In order to make-up missed assignments, you must contact me and provide documentation within 24 hours of the assignment due date.

- If the student has a Written Warning of academic dishonesty reported in CID courses, the student may NOT resubmit the assignment, and the instructor will follow the procedure detailed in <u>Policy</u> <u>13.99.99.R0.03</u> for Undergraduate Academic Dishonesty and report the incident to the Provost Office.

Use of Artificial Intelligence
