COURSE DESCRIPTION

This course offers an opportunity to discuss and apply principles, tools, and methods to successfully implement change and innovation within organizations. Focuses on utilizing diversity within the workplace to create an environment conducive to creativity and innovation while also realizing the external forces that lead to change.

STUDENT LEARNING OUTCOMES

Completion of this course provides the student with the knowledge to:

- 1. Demonstrate the ability to identify and discuss why organizational change is necessary
- 2. Recognize the limits that managers of change face
- 3. Discuss the difference between incremental and radical innovation and the importance of each
- 4. Recognize the internal and external issues that lead to change and innovation
- 5. Demonstrate the ability to apply steps that lead to organizational change and innovation
- 6. Discuss the importance of cultural diversity to organizational change

REGULAR AND SUBSTANTIVE COURSE INTERACTION

As a general guide, students enrolled in a three semester hour course should spend one hour engaged in instructional activities and two to three hours on out-of-class work per week in a semester. Educational activities in this course are designed to ensure regular and substantive interaction between students and faculty.

COURSE REQUIREMENTS

ASSESSMENT

Interview: 25% Students will conduct interviews with leaders of organizational change (20%). Prior to conducting the interview, a plan of action (5%) will be submitted. Please see D2L for more details.

Book Summary/Review: 15% Students are required to read the assigned book and write a book summary/review. Please see D2L for more details.

Article Summary: 20% There will be two article summaries each worth 10% of your grade. Please see D2L for more details.

Discussion Board: 35% Both articles (10% each) and the book (15%) will have multiple discussion topics that you will be required to participate in. Discussion board topics require a minimum of one post and **three replies** to fellow students. Discussions may be completed and submitted prior to the posted due date, but keep in mind that you will be graded on quality of content. Spelling, punctuation, capitalization, and grammar errors will have a negative impact on your discussion grades.

Syllabus and Calendar Quiz: 5% Students will be required to take one quiz covering material found in the syllabus and calendar.

All assignments must be submitted to the appropriate assignment submission folder within D2L.

IMPORTANT: Assignments may be submitted early, but I will count off one letter grade for each day an assignment is late. Exams, quizzes, and discussions will not be opened after the due date. No extra credit work will be assigned under any circumstances. The following are the ONLY acceptable excuses for missed assignments. In order to make-up missed assignments, you must contact me and provide documentation within 24 hours of the assignment due date.

- If the student has a Written Warning of academic dishonesty reported in CID courses, the student may NOT resubmit the assignment, and the instructor will follow the procedure detailed in <u>Policy</u> <u>13.99.99.R0.03</u> for Undergraduate Academic Dishonesty and report the incident to the Provost Office.

Use of Artificial Intelligence
