COURSE INFORMATION

Course Description: This course is a survey of the institutions and policies of the American governing bodies. You will learn about formal and informal institutions of the national government and how they play into the creation and implementation of public policy. Topics considered include the legislative, executive, and judicial branches, bureaucracies, public policies (formulation and implementation), and global forces that continue to shape our understanding of the relationship between the people and government.

• Please note that you will not be taught what to think about political issues in this course. Rather, you will be provided with the knowledge to determine how to think about political issues for yourself.

Student Learning Outcomes:

1. Critical Thinking: Students will be able to differentiate between fact and opinion.

2. Communication: Student communication will be clear, purposeful, and make appropriate use of evidence, data and technology as applicable. In written, oral, and/or visual communication,

A&M-Commerce students will communicate in a manner appropriate to the audience and occasion, with an evident message and organizational structure.

- 3. Personal Responsibility: Students will be able to understand their role in their own education.
- 4. Social Responsibility: Students will demonstrate awareness of societal and/or civic issues

- 7. Describe separation of powers and checks and balances in both theory and practice.
- 8. Demonstrate knowledge of the legislative, executive, and judicial branches of the federal government.
- 9. Evaluate the role of public opinion, interest groups, and political parties in the political system.
- 10. Analyze the election process.
- 11. Describe the rights and responsibilities of citizens
- 12. Analyze issues and policies in U.S. politics.

COURSE REQUIREMENTS Minimal Technical Skills Needed

Instructional Methods

Each week module will consist of and involve quizzes, and discussion boards over the assigned readings and any other supplemental readings the instructor wishes to add. You will regularly be asked to contribute your opinions and answer questions about the readings.

Students are expected to complete the assigned readings and engage in class discussions/writing assignments. Complete all assignments. Be prepared to discuss the topics presented in class. Be courteous to and respectful of your fellow students and instructors.

Assessments

Note: Personal computer and internet connection problems do not excuse the requirement to complete all course work in a timely and satisfactory manner. Each student needs to have a backup method to deal with these inevitable problems. These methods might include the availability of a backup PC at home or work, the temporary use of a computer at a friend's home, the local library, office service companies, Starbucks, a TAMUC campus open computer lab, etc.

Participation: With this being an online course, you will need to login to D2L and access this course regularly throughout the week and/or modules. Not logging in and keeping up with due dates and weekly readings and assignments will have a detrimental effect on your grade.

Discussion Boards: For each module there will be two discussion boards that you will be responsible for answering. You will also be responsible for responding to at least one other classmate. Discussion boards should answer all parts of the prompt and have some substance. This goes for the peer response as well. Your original post will worth 15 points and your peer response will be worth 10 points for a total of 25 points. Your original post needs to be at least 300 words (do not use filler words to get make the count, I am still grading for substance) and your peer response needs to be at least 150 word count.

Exams: There will be four exams given during the semester in addition to a final exam to be administered during finals week. They comprise a significant portion of your grade, so it would be beneficial to be prepared for your exams. <u>Since there is a multi-day window for exams</u>, <u>makeup exams will not be given</u>. If you have an athletic or academic reason as to why you are not able to take the exam during the window it is open, you must email me IMMEDIATELY so that other arrangements can be made. This means emailing me <u>BEFORE/DURING</u> the exam window, not after the window has closed..

Quizzes: Quizzes will be given weekly and can be over the subject matter or **current topics/events.** Questions for the quizzes will come from the week's lectures, assigned readings and any breaking news (political, sports, or pop culture related). Quizzes will be given every week during the semester. **Quizzes cannot be made up if they are missed.**

Final Paper: A final paper will be assigned/open during Module 2 and be due by December 8th. This a hard deadline with no wiggle room due to the academic calendar set by the university. You will have nearly the whole semester to complete this paper. The final paper should be 4-6 pages double spaced in Times New Roman with 12 pt.font (not including the cover page or reference page(s)). APSA formatting will be used unless otherwise discussed with me. Your paper will need to have a minimum of five academic or scholarly cited sources. If you are unsure what an academic source is, please ask. Points will be deducted for not using appropriate sources. Formatting will be a part of the grade so please make sure you are adhering to them so you do not lose points. The final paper is due December 8th by 11:59 pm.

Extra Credit: Extra credit will be given at the instructor's discretion. I will NOT create extra credit for any student at any time because they "need to get" a certain grade or because they have chosen not to do the original assignments assigned. I do not "give" grades rather you EARN your grade. I cannot stress this enough: keep up with your assignments and your grade in the gradebook throughout the whole semester and not just at the end.

Submitting Assignments & Late Assignments: Late work will not be accepted. Each assignment is given with enough time to complete it. You are responsible for attaching the correct assignment to the correct folder in D2L Brightspace. Once you submit your assignment you should always click on the document to guarantee that it has been submitted correctly, or no

document is counted as failure to complete the assignment on time. Poor internet connection, dead laptop batteries, etc. are not valid reasons for an assignment not being completed. If for some reason you are having difficulty uploading your assignment please email me a PDF version before the deadline and explain the situation, but please only use this as a last option.
