Course Description

CJ 383 - CJ Administration and Mgmt

Hours: 3

Criminal Justice Administration and Management

The study of criminal justice administration (i.e., police, courts, and corrections) with special emphasis on applying theoretical concepts to practical planning and application, including the policy-making process, implementation of new policy, and policy assessment. Pre-requisite: CJ 101

Student Learning Outcomes:

1. The student will obtain a basic understanding of important issues in criminal justice planning, administration, and management;

- 2. The student will learn to utilize critical thinking skills;
- 3. The student will learn how to apply course concepts to 'real life' criminal justice administrative/management situations/issues;
- 4. The student will be an active and engaged participant in discussion forums by analyzing and evaluating information presented within the textbook, external readings/resources, student research, and class activities.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Using the learning management system (D2L), using Microsoft Word and PowerPoint, using presentation and graphics programs, and Turnitin. Written and oral communication skills; reading; memorization; critical thinking. You should know how to access a Web site when given an address, use the features of your Web browser, download files, attach files to emails, and use word processing software, ...etc.

Instructional Methods

This course is designed in a format that is delivered asynchronously 100% online. In the online environment, students will be engaged in discussion forums and weekly unit completion of materials that will lend success to completion of the course work. The weekly lessons will be released by Sunday at 5pm.

Each week/unit starts on Monday and ends on Sunday at 11:59pm CST and your grade for activities will be posted as soon thereafter as possible. Typically grades are returned within one week of due date. See due dates for specific assignments posted in MyLeo/D2L.

This course will provide a variety of activities and assessments to assist you in achieving the outcomes/objectives for the course. You will work toward achieving these outcomes through discussions/comments, written assignments, video assignments, quizzes and exams.

Student Responsibilities or Tips for Success in the Course

The student must log into the course through myLeo multiple times throughout the week to complete weekly assignments and post and respond on discussion boards. The student must commit serious time to weekly readings as well as preparation for scheduled exams and all other assignments. Students should check email daily and set up automatic notifications for announcements and other reminders in the D2L system. Any changes/updates to assignments will be posted mainly through the "Announcements" tool on D2L. Students should ask questions of the professor if there is any information that is not fully understood. Reach out to the professor by email to schedule a one-on-one virtual office visit if desired.

Students must cite in-text using APA style for all assignments. All written work is subject to Turnitin review. Any student who plagiarizes will receive a zero on the assignment in question and face potential further University disciplinary procedures.

Netiquette Expectations: When sending an email please put the COURSE NUMBER (CJ 383) in the subject block of the email as well as signing your name. Further – per University requirements, please contact me using your University e-mail account.

Do's • Keep all postings to class-related content, such as the textbook readings, videos, and assignments. • Use caution when discussing personal matters; the discussion board is for general comments. • Ask each other for advice, suggestions, and tips to improve the quality of class work. • Encourage each member of the class to do the best work possible.

Don't's • Don't challenge or attack others; the discussions are meant to stimulate conversation, not create contention. • Avoid all defamatory, profane, threatening, offensive, or illegal materials; do not post anything in a message that you would not want the world to see, or you would not want anyone to know came from you. • Avoid using the discussion board as a forum for complaints; any relevant issues should be brought to the professor's attention in a private e-mail. • Don't use inappropriate language toward other students and/or the professor. Any violation of the standards of appropriate behavior online will be reported to the Dean of Students and appropriate disciplinary action will be taken by the college.

Assessments

- 1. The student will obtain a basic understanding of important issues in criminal justice planning, administration, and management; accomplished by developing the writing assignment and completing the exams.
- 2. The student will learn to utilize critical thinking skills; by developing the writing assignment, completing the exams and case study submissions, and participating in discussions and responding through comments to classmates.
- 3. The student will learn how to apply course concepts to 'real life' criminal justice administrative/management situations/issues; by developing the writing assignment and completing the case study submissions.
- 4. The student will be an active and engaged participant in discussion forums by analyzing and evaluating information presented within the textbook, external readings/resources, student research, and class activities: by participating in discussion forums and responding through comments to classmates.

Writing Assignment: (125 points)

Agency Selection (5 points) due - 10/29/23 Full Report (120 points) due - 12/3/23

I advise you to start early in the semester on this project as it requires planning!

This writing assignment aims for you to examine one specific criminal justice agency's administration and management functions by analyzing the areas outlined in the "Writing Assignment - Full Report" assignment on D2L, including interviewing two people at the selected agency.

Essay Format: 12 pt font, Times New Roman, 5 pages of content minimum, reference sheet required, APA format and APA citations required. Minimum of 4 peer reviewed journal articles or academic books outside of your textbook to support your findings and compare/contrast with information learned about the agency. See grading rubric and additional assignment information in D2L (MyLeo).

Exams

There will be five exams in the course worth 75 points each (375 total course points). They will cover assigned chapters/readings for that section and the due dates will be posted in the course calendar. Exams will consist of essay, multiple choice and true/false questions. You may use your notes/book for the Exam. Since the exams are timed, it is highly recommended that you read each chapter thoroughly and take notes on key concepts and statistics. Essays require essay format and at least two paragraphs of content. You will have 1.5 hours in which to take the exam. You may take the exam one time.

Participation/Discussions: (8 posts/comments at 50 points each = 400 points) Eight discussions will be posted throughout the semester worth 50 points each total (40 points for the initial post and 10 points for your comments). Discussions on topics must be completed during the week(s) we discuss the course material. Posts are due on Saturday by 11:59 pm, and comments are due by Sunday at 11:59 pm of the week assigned.

Introduction (1 Introduction post not graded) Every student must introduce him- or herself by the fifth day of class (Friday) during Week One. This information will be entered as a threaded discussion. You will receive 10 extra credit points for completing this task by the deadline. See introduction assignment post details in D2L.

Discussion Posts

The Discussions in this class will focus on the specific assignments connected to each week. Each student is expected to participate in the weekly discussion by responding to ideas(s) presented by the professor. A minimum of one initial discussion per week is required by Saturday at 11:59 pm of the week assigned, and two peer responses by Sunday. This must not be all in one day. If desired, students may post earlier than the absolute due date but no later than the identified date. Five (5) points will be deducted for posts made after the Saturday deadline. The post will close on Sunday of the week assigned. Posts cannot be entered once the discussion is closed (Sunday at 1:59 pm).

The **Discussions** are directly related to the assigned lecture material. Upon completing the assigned lecture material, you are expected to engage in an **ongoing** discussion/debate with your classmates. Your contributions to the discussion forums will be graded for **quality** and a **detailed analysis** linking the material to a critical appraisal of theory, policy, and practice. You must integrate course material (textbook) and outside material into your post and cite it properly. In all cases, students must have **one in-text citation and provide a full bibliography/works cited at the end of their post for all citations mentioned in the post in APA format (See information later in the syllabus for more information on citing utilizing APA citation format).**

These posts should be **the equivalent of 1 page in length or a minimum of 250 words**. The discussion assignment is located in each unit Week by clicking on the Discussion link.

Posts are due by Saturday at 11:59 PM CST during the week assigned.

Comment Posts

Comment posts are responses to the discussion posts you and your classmates post each week and are due by Sunday by 11:59 pm. You are **required** to make a minimum of **two** comments for each discussion. I strongly encourage you to engage your colleagues well past the two-comment minimum to maximize your meaningful discussion and learning opportunity.

Comment posts should be meaningful and at least one paragraph in length. Merely agreeing or disagreeing with a classmate will not be looked upon favorably, resulting in a loss of points. A meaningful post moves the discussion forward in some substantive

way by providing one's perspective, additional information through research, or reframing the discussion in some new way. You are expected to engage in an **ongoing** discussion/debate with your classmates. Your comments will be graded for **quality** and **relevance**. Your comments will also be graded based on your ability to engage in critical thinking.

NO LATE COMMENTS ARE ACCEPTED. All comment posts are due by Sunday at 11:59 PM of the week assigned.

Assessment Method: Comments and the Discussion Post will be graded using the Discussion/Comments Grading Rubric. See information in D2L/Brightspace for Discussion Rubric. The discussion and comments for each week will be graded together and posted as one grade (Discussion = (40) + Comments 2 @ 5 points each (10) = 50 points).

Case Studies – 50 points

In your book there are case studies at the end of each chapter. You will need to choose one case study for each section of material covered and submit it by the date listed on the course calendar. Submissions are to include which chapter the case study is from and a response to all discussion questions listed under the case study prompt. Your response needs to be in your own words and offer a complete, academically supported response to each prompt listed in your book after the case study. Add in examples and information learned from lecture and book content to show you understand the material. Your total submission should be at least one page in length. Each submission is worth 20 points (5 submissions at 20 points each = 100 points total).

We cover 5 main areas of content – Justice Administration (CH 1-3), The Police (CH 4-6), The Courts (CH 7-9), Corrections (CH 10-12) and Issues Spanning the Justice System CH 13-15). You may choose a case study from any chapter in the area of content. The "Justice Administration" content area covers chapters 1-3, you may choose a case study from any one of those three chapters to submit by the deadline for Case Study Submission #1. For Submission #2, you may choose a case study from chapters 4, 5 or 6. For Submission #3, you may choose a case study from chapters 7, 8 or 9. For Submission #4, you may choose a case study from chapters 10, 11 or 12. For Submission #5, you may choose a case study from chapters 13, 14 or 15.

APA Citation Format Policy

It is very important that you learn how to cite properly. In some ways, citations are more important than the actual text of your paper/assignment. Therefore, you should take this task seriously and devote some time to understanding how to cite properly. If you take the time to understand this process up front, it will save you a significant amount of time in the long run (not to mention significant deductions in points).

In the social and behavioral sciences (including Criminal Justice), we use APA (American Psychological Association) format. As a rule of thumb, one cites whenever they are paraphrasing other people's words or when they quote other's words directly. You may learn to cite from a variety of different sources including the sources listed below.

Therefore – the Writing Assignment will receive a 20% deduction in points if submitted after the due date and cannot be accepted beyond **one week** of the due date unless you have contacted me beforehand to explain any circumstances and we have

agreed to an extension **before the due date**. The Case Study Submissions will receive a 20% deduction in points if submitted after the due date and cannot be accepted beyond **3 days** of the due date unless you have contacted me beforehand to explain any circumstances and we have agreed to an extension **before the due date**. Late comments on discussions will not be accepted. When a discussion is closed it cannot be reopened for late submissions. Quizzes cannot be made up. Exams will only be allowed a late submission under extenuating, documented circumstances. Written assignments and discussions cannot be regraded or redone.
