## General Course Information

## **Course Description:**

The course focuses on the study of marketing problems. Problem areas to be studied include market and profitability analysis, marketing planning, strategy, and control. The course will also examine the key parts of a business strategy and a marketing strategy. Issues such as conflicting strategic objectives, particularly under risk and uncertainty, will be evaluated and decision-making processes will be studied. Prerequisites: Mkt 521, Mkt 572, Mkt 547, Mkt 568, Mkt 524

- 1. Understand what strategic marketing
- 2. Understand and measure the value created by marketing
- 3. Comprehend the importance of decision making and critical thinking in marketing
