- If you get less than or equal to 60% in the retaken exam, then the grade of the retaken exam will be the grade of your midterm exam.

**Homework:** 30%, Homework will be assigned in **each lecture** twice a week on a regular basis. All assignments of the week will be due on Tuesday in the following week. The course website keeps a log of the course material that you visit or download. Student name and homework number should be included in the filename for each week. Selected assignments and problems will be graded, but all problems should be worked out for full **homework score**. You may work in groups unless otherwise instructed, however the work you turn in must be your own. **Late work** might not be accepted unless legitimate reasons are presented.

### **Course Description**

This is the first part of a two-semester course in Introduction to Real Analysis. Topics include real number system; sequences and series; limit, continuity and differentiation; sequences and series of functions; the Riemann integral.

Prerequisite: LvI U MATH 2415 Min Grade C or LvI U MATH 314 Min Grade C.

#### **Student Learning Outcomes**

Upon successful completion of this course, students will be able to:

- 1. Describe the real line as a complete, ordered field;
- 2. Use the definitions of convergence as they apply to sequences, series, and functions;
- 3. Determine the continuity, differentiability, and integrability of functions defined on subsets of the real line;
- 4. Apply the Mean Value Theorem and the Fundamental Theorem of Calculus to problems in the context of real analysis;
- 5. Write solutions to problems and proofs of theorems that meet rigorous standards based on content, organization and coherence, argument and support, and style and mechanics;
- 6. Determine the Riemann integrability of a bounded function and prove a selection of theorems concerning integration;

- 7. Recognize the difference between pointwise and uniform convergence of a sequence of functions;
- 8. Illustrate the effect of uniform convergence on the limit function with respect to continuity, differentiability, and integrability.
