Course Description:

An introduction to financial accounting concepts and financial reporting, with the focus being on how decision makers analyze, interpret, and use accounting information. Emphasis is given to how accounting measures, records, and reports economic activities for corporations and on the relationship between accrual and cash flow measures in interpreting accounting information.

What does Inclusive Access mean? MyLeo/ D2L opens the first day of classes. You should receive an email about Inclusive Access for this course. When you register to take this class you are automatically charged for access and the e-text (unless you opt out- not recommended). You do not have to purchase the e-textbook or access because they are included in your tuition and fees. You will login to MyAccountingLab (MAL) from the Content area of D2L. Upon login/registration to MAL, you will be given the option of ordering a "print copy" of the textbook. A used textbook is fine. The print version is highly recommended for this course. All coursework will be completed in MAL.

Note about this book The 14th chapter in this textbook (The Statement of Cash Flows) will be the first chapter you will study in your Principles II – ACCT 2302. The e-text you will receive with Principles II will not contain this chapter, so you will need to retain your Principles I textbook (Financial Chapter 14).

Student Responsibilities:

- 1. Read assigned material on schedule. Make sure you do not fall behind.
- 2. Complete all assignments on time in MyAccountingLab (MAL). Homework completed by hand will not be accepted. In fairness to persons submitting assignments in a timely manner, assignments turned in late will not receive full credit.
- 3. Prepare for homework, examinations, and quizzes.
- 4. Watch assigned videos in their entirety.
- 5. Attend and/or watch recorded live lectures.
- 6. Watch LO videos in MAL and utilize other resources in the MultiMedia Library (MAL) to learn the material.
- 7. You are more than welcome to work together on homework, but your answers must be your own. Answers that appear to be plagiarized will not be considered.
- 8. Include the course section in all email correspondence, preferably in the subject. Poorly written emails (no salutation, incomplete sentences, etc...) will not receive a response.

Teaching Procedures:

The class will be conducted online using myLeo Online/D2L (TAMUC LMS) and MyAccountingLab (MAL). All coursework will be completed in MAL (except the Sustainability Module in D2L). Recorded live lectures and other course content will be posted in D2L. Reading the material is required because of the complexity of the material in this course. Chapters 1-4 are vital to your understanding of Accounting; read them thoroughly. Repetition is how this material is learned. The assignments will force repetition and therefore, assist in absorbing the material. Although many of the learning points included in the readings will be covered in the class lectures, all the areas covered in the readings will not be part of class presentations. You are encouraged to participate in class and communicate with the other students in the course. Disruptive or rude behavior will not be tolerated.

Sustainability Education Module (D2L) – You have a module in D2L that covers the Triple Bottom Line concept of sustainability, which is that businesses must consider people, profit, and planet in their bottom lines. This module will contain videos, a self-assessment, a discussion board, and an objective quiz due 1/31/23. Please see the grading section of the syllabus for the points for this module and the class schedule for when you will need to complete the assignments. There will also be a survey emailed on 2/1/23 that will be due 2/15/23. I recommend focusing on this module FIRST so that you can move on to Chapters 1-4 ASAP. Chapters 1-4 are the foundation of Accounting, and the more time you have to spend on these chapters, the more successful you will be in this course.

This class has a **semester project**, completed in MAL, due 3/4/2023. Even though the project is not due until March, it is vital that you complete the project as each topic is covered in the course. The project is the best way to prepare you for the homework and exams this semester. If you wait until right before the due date to begin the project, it is likely your grade will suffer. Please budget your time appropriately. It is possible to make a 100% on your project, if you allow sufficient time to complete it, which will help

your semester average tremendously. To discourage procrastination, I will not answer questions asking for help with the semester project after 3/2/2023. Prior to that, feel free to ask questions. I am here to help.

There will be no extra credit offered on an individual basis to bring up your grade at any point during the semester. Offering extra credit for a student would not be fair to the entire class. The last date to submit homework for the semester is **5/6/2023 for any credit**. No homework will be accepted after this time. Make sure to stay on top of the homework and quiz due dates. Even though coursework is not due every week, please budget your time to complete a chapter each week. Stay on top of the coursework. Getting behind will result in a substantial amount of time required to catch back up and could affect your grade significantly.

<u>Missed exams cannot be made up!</u> All exams must be taken on the scheduled days. Special arrangements can be made <u>ahead of time</u> for extenuating circumstances. All students, including athletes, who will miss an exam must notify the instructor <u>PRIOR</u> to the exam being given to reschedule your exam. I do drop the lowest homework and quiz grades at the end of the semester.
