## **COURSE INFORMATION**

Text: Abbott, Patrick L., Natural Disasters, 9th ed., Boston: McGraw-Hill

#### **Course Description**

A study of a wide variety of natural disasters and hazards, their causes, and their impacts on human populations and nature. Included are meteorological, geological, biological, cosmological, and human-made hazards.
