

Course Information

Textbook (required): Lifelong Motor Development (8th ed.), by C. Gabbard.



Catalog Description: This course examines basic concepts and contemporary issues associated with physical growth and motor behavior (perception to action) across the lifespan. Topics include physical and neurological growth, perception, motor control, and environmental influence. Prerequisites: HHPK 154 with a minimum grade of C or [HHPK 1338](#) with a minimum grade of C, 2.5 GPA.

Course Objectives

Specific course objectives are included in the textbook and identified on the schedule below.

Generally, upon completion of the course, the student should be able to...

1. Define and discuss motor development and all associated terms.
2. Discuss the potential impact the quality of physical education programs might have on the development of motor skills.
3. Identify appropriate movement activities based on the mover's age and developmental readiness.

COURSE REQUIREMENTS

You will be expected to use D2L, to use Microsoft Word and Microsoft Excel. You will also be required to use video software and upload to YouTube.

Instructional Methods

Course will include lecture, handouts, reading, live discussion, and videos to supplement course material.

Assessments

Tests

Each test will have several types of questions: define and explain, short answer, essay, fill-in-the-blank, true/false, etc. Study the material indicated by the objectives listed on the schedule. Also study material that was supplied by notes and supplemental materials. Be able to APPLY the information learned, not just recite definitions and lists. For each test, you will have an allotted amount of time. At the end of that time, your test must be submitted. The “cumulative essay opportunity” will be discussed in detail later in the semester. Students with a cumulative 90% on all coursework just before the CEO will not be required to take the CEO.

Assessment Activity

After we have covered assessment techniques, you will administer a developmental assessment, as assigned to you. Instructions and more information will be provided online.

Online Quizzes

Before some classroom days, there will be a quiz in the online portion of the class that you must submit no later than 11:59pm on the specified date. Each quiz will require that you read the corresponding material in the textbook. This will help you be prepared for class discussion and/or review information covered in class. The quizzes will count for 10% of your entire grade (100 points).

Assignments

Within the online part of the class, you will find instructions for 2 assignments. This part of the course will count for 5% of your entire grade (50 points).

Service (2)

You will be required to participate in two service activities related to motor development, one from Section A and one from Section B (see details online). Service A activities do not require a written report; service B activities will require you to complete a written report, due by 11:59pm TWO DAYS after the observation. Drop the report in the assigned place ONLINE, with the document named "lastname service B." An example report is provided online.

Creative movement

You will create a movement experience to music specific to a certain stage or phase, based on the motor development milestones typically reached by that age. More details will be provided in class and online. You WILL have to post to YouTube, so if you do not have an account, create one and figure out how to video, edit, and post.

Activity Days

Besides the "lecture" part of the course, we will have some "moving" or "activity" days, where we will be doing some physical activity. On activity days, you need to be dressed appropriately (wearing athletic shoes and athletic clothing [no denim, dress clothes, flip flops, sandals, boots, etc]). Some activity days are listed on the syllabus, but I may also announce additional activity days in the preceding class meeting; if you are absent, it is your responsibility to find out if the next class meeting is an activity day. Material covered on activity days will be included on exams.

Absences/Tardiness

I have discovered over the years that students who do not attend class regularly or are late to class do not do well! Do not miss class! In addition, being late to class is disruptive, rude, and detracts from the learning of all students. If you are late to class, do not disrupt class. Use the time to study instead.

Extra Credit

Extra credit opportunities will be provided during the semester. Earning extra credit is something that I suggest ALL students do! There will be opportunities in which all students can participate, but not every opportunity will be available to every individual student; some are dependent on age, gender, time of availability, etc. I will not assign EC in the form of papers or extra coursework. The maximum number of extra credit points you can earn from all sources combined is 40.

Other helpful information

CRUCIAL INFORMATION:

- CHECK YOUR EMAIL for critical updates from me about meeting places, etc.
- BEFORE you come to class each day, I HIGHLY recommend that you have read the assigned chapter in the textbook AND viewed the lectures for that chapter as well. To make taking notes easier, you can even screenshot, then cut and paste the slides into a Word document and bring those to class.
- Class time will be 100% active; be prepared to WORK HARD.
- Know how to use D2L WELL! Know how to record yourself with GOOD AUDIO (so those watching can hear the music and hear you). Know how to post on YouTube. (This is for creative movement assignment.)

Chat Sessions

Periodically throughout the semester, I will announce a “chat time” where you can meet with me and other students to talk about motor development. This is not me re-lecturing, nor is it me telling you what is on the test(s). It is an opportunity for you to engage your mind in the topic and enhance your grade (hopefully) by learning at a deeper level.

Statement on Student Behavior

All students enrolled at the University shall follow the tenets of common decency and acceptable behavior conducive to a positive learning environment (see Student’s Guide Handbook). I have zero tolerance for disrespect for the learning environment or other human beings, present or not. - 1 Students are expected to be in class, seated, on time.
- 2 An “excused absence” is defined as a documented university approved activity. The instructor reserves the right to change the content or format of all make-up work. The student is responsible for making up missed work. Online quizzes must be completed regardless of excused absences. They will not be reopened after the due date has passed.
If the absence is for one of the reasons listed below, you will be able to make up the work (within two business days). To reserve this right, you MUST provide written documentation on the day of your return to class (a copy that I can keep). Please notify me ahead of time if you know you will be absent.

 - Participation in an activity appearing on the University’s authorized activity list.

- 6 While you are in class, I expect you to participate. That means that you should a) actively prepare by reading the assigned materials, b) TALK (ask and answer questions), c) bring your notes and textbook, d) bring

your ideas, and e) refrain from anything that is not class-related during class (newspaper, reading for another class, text messages, etc). Students who choose to disrupt class by not participating will be asked to leave.
