COURSE DESCRIPTION

Honors colloquia are scheduled weekly to provide Honors students the opportunity to discuss timely local, regional, and world issues as well as other enlightening topics with faculty, administrators, and other honors students. The Honors colloquium is informal as well as educational. The overall goals are to provide opportunities to be motivated by other people's enthusiasm for their field, to be exposed to new ideas, and to share conversation with other intellectually curious students. This colloquium will also be a space in which you will continue to prepare for your thesis defense and for the Annual Research Symposium. The purchase of books or other materials is not required for this course.

COURSE OVERVIEW

A. Attendance

You are allowed one unexcused absence this semester. If you accumulate more than one absence, you will not receive credit for the class. Further, once here, please treat guest speakers with the attention and courtesy that they deserve. **Please turn off cell phones and do not engage in texting while in class.** During discussion, students are expected to participate actively in what should be lively conversation and even debate—come to class prepared to engage with our guest speakers and with each other! Of course, all students enrolled at the university shall follow the tenets of common decency and acceptable behavior conducive to a positive learning environment (see current Student's Guidebook).

B. Graded Items

To gain credit for HC 400, students are required to:

- Attend class and participate actively in class discussion.
- Complete a draft for the Annual Research Symposium presentation. Further information will be provided in class.
- Write a Reaction Paper responding to one of our class sessions, meaning either a
 presentation led by a guest speaker or an impactful discussion we have in class
 ourselves. Further information about the Response Paper is located below.

 Write a synthesis paper that reflects on your overall education. Further information will be provided in class.

Response Paper: Further Information

The Response Paper assignment asks you to reflect on a class discussion that drew your particular attention, provoked thought, or was otherwise meaningful in some way. The paper may cover some of the following points:

- What was said that you agreed with?
- Or disagreed with?
- Can you connect an aspect of what you learned from the colloquium session to another event you have read about or heard about or observed or even experienced in your own life?
- What interested you the most?
- ➤ Least?
- What would you have done or said differently?

Obviously, you do not have to answer all of the above questions, nor do you have to respond to any one of them. What your paper should show is your mind at work—much like a book critic or movie critic does when she or he writes a review. I am asking you to write a paper that contains intellectual reflection on whatever topic you choose—I'm looking for something that goes beyond being merely a series of notes you take and write up. For length, shoot for a minimum of two double-spaced pages of type with one-inch margins. Students who miss a deadline will be allowed to submit a late paper for partial credit depending on the quality of the paper. Please be mindful of the deadlines to avoid a mistake and a reduction in your grade.
