Course Description:

This course presents the fundamental concepts and techniques of digital signal processing (DSP). Time domain operations and techniques include difference equations and convolution summation. This course also covers Z transform methods, frequency- domain analysis of discrete-time signals and systems, discrete Fourier transform, and fast Fourier transform. FIR and IIR filter design techniques. This course emphasizes the frequency response of discrete-time systems and its relationship to analog systems. The course has an associated simulation experiments set, which will require the use of simulation software (e.g. MATLAB, LABVIEW).

Prerequisites: [EE 430](#) with a minimum grade of C.

Student Learning Outcomes:

After successfully completing the course, students will be able to:

1. Describe the basic theory in DSP
2. Demonstrate the concepts in DSP such in discrete-time signals & systems and spectrum representations
3. Analyze the impulse response, signal flow graph using difference equations, stability determination and Z-transform
4. Combine basic digital filter concepts to design digital filters in various conditions.
5. Apply software packages to signal processing applications.
6. Acquire and apply specialist in-depth knowledge of a DSP topic.
7. Design block diagram systems for signal interpolation and decimation.
8. Develop programs which implement the digital filters used in DSP Processor

Homework Assignments: Homework Assignments are due at the beginning of class, delivered in the appropriate drop box. No late submissions will be accepted. Some homework assignments will include the submission of simulation files created in MultiSim. Any file that is flagged as infected with malware or viruses will be receive a grade of zero. The instructor will use Norton Internet Security, and the student is advised to use something at least as good as NIS.

Exams and Quizzes

LearningStudio Notifications
