This course covers the following topics: This course is designed to introduce the behavior and design of steel structural members according to the limit states design concept. The behavior and design of tension members, compression members, laterally restrained and unrestrained beams, beam-columns and design of connections will be discussed. Students are expected to obtain basic knowledge about the design and failure mode of steel structural members after finished this course. (Prerequisite: CONE 332).

1. Design of tension members, compression members, laterally restrained and unrestrained beams, beam-columns, and connections.
2. Design and analysis of steel buildings.
