# **Course Description**

This course is an overview of the nature and scope of the administrative issues in the sport industry and recreational agencies and will expand the students' understanding of management theories and their application to sport and recreation administration.

#### Assessments

<u>Quizzes</u>: You will take several short answer/essay-style quizzes that cover the lecture recordings and assigned readings (will be scored out of 25pts).

<u>Discussions</u>: You will participate in several discussions throughout the course of the semester. You are expected post an initial post and respond to at least 4 of your classmates' posts to receive full credit.

<u>Written/presentation assignments</u>: You will be asked to write short papers and complete presentations on a variety of issues/topics. These assignments will have instruction sheets for them and will be graded out of 100pts.
