Principles of adapting physical activities to individual needs will be studied. Instructional strategies, screening and testing procedures and modification of equipment will be emphasized. Patterns of organization and administration of programs will also be addressed.

- 4) articulate the need for special physical education & lifetime exercise and therefore have developed competencies to effectively implement Public Law 101-476, Individuals with Disabilities in Education Act (IDEA) of 1990 (and reauthorizations of 1997, and 2004) and related legislation including Public Law 101-336, 1990, The Americans with Disabilities Act (ADA), and the No Child Left Behind Act (NCLB) of 2004, in all physical activity/exercise settings.
