Students will be given a preparation grade for each lesson. There will be a semester jury, as well as a technique jury. The final grade will be an average of weekly preparation and attendance (70%) and the semester (15%) and technique (15%) juries. Weekly preparation for lessons includes having playable reeds. In addition, students are expected to bring in reeds in progress to their lessons.

Assessments
