COURSE INFORMATION

Course Description

Three semester hours. A continuation of the detailed study of financial accounting principles and procedures begun in Accounting 321. Emphasis will be given to accounting for long-term liabilities and investments, stockholders equity, income recognition, leases, accounting changes and errors, and financial reporting and analysis. Prerequisites: ACCT 321.



ASSESSMENTS

Accounting is a very challenging topic and requires a lot of practice. The weekly assignments, due on the schedule below, are key parts of this course and critical to your success. These assignments are to be completed in D2L and WileyPlus.

Homework

Read and outline the chapter before attempting homework. Homework assignments are worth 10 points each. Graded homework is meant to practice concepts at a higher level of difficulty. Assignments are due in **WileyPlus** by **9:00pm** on **Sunday** of that week. They have no time limit and allow **two** attempts.

Quizzes

Chapter quizzes provide feedback on how well you retained and mastered material in preparation for exams. Quizzes are worth 5 points each due in **WileyPlus** every **Sunday at midnight**. They have a duration of 30 minutes and allow **one** attempt.

Exams

This course requires two midterm exams and a final exam. Refer to the Course Calendar for a detailed breakdown of exam dates.

Make-up exams will be considered only under extenuating circumstances. Extenuating circumstances include hospitalization, medical emergency, physical injury, or death of an immediate family member. Proof of the extenuating circumstance is required for make-up exam approval. Make-up exams will be scheduled within three days of approval.
