**Course Description**

This course is a study of the principles and theories of child growth and development in early childhood education. Course content centers on the physical, cognitive, affective, and social development domains. Students will be required to observe the development of a young child outside of the classroom in order to complete a comprehensive child study project.

**Student Learning Outcomes**

As a result of participating in this class, the student will be able to:

1. THEORY: Connect the concepts, principles, stages, and theories of child development to pedagogy.
2. RESEARCH: Analyze research on child development to promote developmentally appropriate and evidence-based practices.

3. **WHOLE CHILD LEARNING:** Develop a toolbox of strategies to support the interdependency of young children's development (physical, social, and cognitive).
4. **THE LEARNING ENVIRONMENT:** Synthesize understanding of child development to create implications for early childhood classrooms and programs.
5. **APPLICATION:** Apply theory and research to investigate child development through a case study.
