Assessments

- InQuizitive Online Interactive Reading Quizzes- Each chapter has an associated interactive reading quiz, which will be taken through InQuizitive (links provided on D2L). You can answer as many questions as it takes to get 100%. Worth 10 points each.
- In-Class Writings- Each week there will be at least one short writing assignment completed in class prompting you to reflect on the additional weekly reading/podcast. **You must be in attendance to complete that session's in-class writing**, as they are used to measure attendance at participation. **Three will be dropped**, giving you some wiggle room in case of necessary absences. Each will be graded on a check-plus (100%), check (85%), and check-minus (75%) scale. Worth 5 points each.
- Final Paper- You will produce an 8-10 page final paper on a topic related to gender. This will be broken into multiple parts. More information can be found on D2L.
