COURSE INFORMATION

Course Description

This course provides a study of current theories and practices of classroom management and discipline in schools. 3 semester hours.

Course participants will explore various philosophical and practical approaches to leading and managing young people as they seek to answer, “how can I create the best environment for students to be able to learn?” Participants will explore their own values and beliefs as they consider how to set limits without punishment, encourage cooperation and inclusivity in the classroom, and transform schools into communities.

1. Compare and contrast various theoretical approaches to classroom management.
2. Develop practical routines and procedures for supporting an effective learning environment.
3. Evaluate strategies that foster classroom community, particularly in a diverse setting.
4. Investigate how their own views, beliefs, and experiences impact classroom culture, community, and the learning environment.
