#### **Student Learning Outcomes**

- Students will develop working definitions related to social justice and intersectionality
- Students will identify examples of social justice efforts on personal and systemic levels
- Students will put their knowledge into practice by addressing a social justice issue
- Students will practice the skills of professionalism and civil discourse with instructor, peers, and community through discussion boards and activities



## **COURSE REQUIREMENTS**

### **Minimal Technical Skills Needed**

In this class, you will utilize the Learning Management System (LMS) entitled D2L for instructional and learning methods, submitting assignments, participating in online discussions, and completing quizzes as assigned. You will need to utilize other technologies such as Microsoft Word, PowerPoint, Search Engines, etc. If you have issues with this system, it is your responsibility to contact the help desk immediately.

### **Instructional Methods**

This class will be run online in an asynchronous format. It will involve various forms of activities, discussions, and critical thinking. It will not be a typical lecture course. The skills and concepts you learn in this course shouldn't be merely memorized – they should be put into practice in your daily lives. Those practices require us to discuss your experiences during implementation. This course will be online and all assignments and interactions will be submitted via D2L unless otherwise noted.

All assignments, schedules, and due dates are subject to change.

### Assignments/Assessments

#### Participation/ Readings / Discussion Boards

Students will complete discussion boards throughout the term related to the weekly readings and activities. Due dates and prompts will be posted clearly in D2L.

Points: 120 total

#### **Journal One:**



Students will complete a 1-2 page journal-style entry responding to the prompts:

- 1. What do I know about social justice and intersectionality going into this course?
- 2. What do I hope to learn from this course?
- 3. What else would you like the instructor to know going into this semester?

This short essay is your chance to share about the experience from your perspective. No citation is required. The response should be 12pt font and double-spaced. Please add a header and title. A minimum of one page of text should be written for full credit.

#### Points: 150

#### **Social Justice Issue Project:**

Students will address one area of social justice of their choice to educate themselves about and act on. This assignment will be graded based on the correlation to the student's chosen topic, their chosen activity, and their written response.

For the written response students should respond to the following prompts:

- 1. What area of social justice did you address? Who does this impact? Why does it matter?
- 2. What did you do to address this area of social justice? What was the actual action and how does it relate to this particular topic?
- 3. Lastly, how do you feel the activity went, and what impact did it have? Did this activity make things better, worse, or no difference? Do you think if you continued this activity or something similar, it would have an impact on your chosen topic?

Students' write-up should be 4-5 pages in length. Additional information about the assignment and/or the student's reactions can be included, but these three prompts must be responded to for each area of wellness. Students can choose to submit this project as a 5 page essay or a powerpoint presentation. If you choose to do a powerpoint presentation, make sure to include a comparable amount of information / text and to answer all the prompts fully.

#### Points: 500

#### **Journal Two:**

Students will complete a 1-2 page journal-style entry responding to the prompts:



- 1. What do you know about social justice and intersectionality now after taking this course?
- 2. What did you like about the course? Dislike?
- 3. What else would you like the instructor to know about your experience this semester?

This short essay is your chance to share about the experience from your perspective. No citation is required. The response should be 12pt font and double-spaced. Please add a header and title. A minimum of one page of text should be written for full credit.
