Course Description

SOC 1306 – GLB/US Social Problems

Credit Hours: 3

The world as we know it, is made up of many layers. Often connecting us to each other through experiences that range from the most positive to the most challenging. Our social problems are diverse in their nature, reflective of the ways in which our world is diverse in its existence. Globally, people are faced with the challenge of injustice and inequality at many intersections of identity. We are forced to reckon with the ways that our actions or lack thereof, impact that of our neighbors. We are forced to bear witness to the atrocities that many face under the oppressive weight of different systems. And then, we are left with the task of choosing how we want to respond to these.

This course is an invitation to think critically about the ways we exist within a world filled with social problems. It is meant to make you question, answer, doubt,

and affirm your stance on issues regarding race, ethnicity, gender, wealth, crime, education, housing, health, war, etc. There is no one answer, but you will find that as you progress in this class, your perspectives will broaden. For it is true, that what some consider the problem, is the solution to others. And through this merge of ideas and perspectives, we can cultivate social change.

By making use of the sociological perspectives available to you through the course materials, you will analyze the concerns of our society on a micro and macro level.

The main goals of the course (SLOs) are:

- Be able to view how social problems affect people at the individual, group, and societal levels;
- Be able to understand the significance of social inequality and race, class, and gender as key factors in our understanding of problems in the United States and worldwide;
- Be able to place specific social problems within a larger social inequality framework;
- Be able to create a comprehensive view of contemporary perspectives on a vast array of social problems impacted by new technologies on social life and how the media depict social issues;
- Be able to apply the sociological imagination and relevant sociological perspectives to all the topics in a systematic manner
