COURSE INFORMATION

Materials

Textbook(s) Required: Calculus, 9th Edition, by James Stewart. ISBN-13: 978-1337624183. *The material covered during the session will be Sections 1.4-1.8, Chapters 2, 3, and 4, then 6.1, 6.2, 6.3, and 6.4 from chapter 6, and finally 7.1 from chapter 7. We may occasionally cover enrichment activities, not in the text.*

Course Description: This course examines differential and integral calculus of functions of one variable, as follows. Topics include limits; continuity; derivatives; curve sketching; applications of the derivative; the definite integral; derivatives and integrals of trigonometric functions; and use of computer technology. Prerequisite: Two years of high school algebra and trigonometry or Math 2312.

The use of a graphing calculator having at least the capabilities of the TI-83 will be helpful throughout the course. TI-89 is highly recommended. A computer algebra system will be used for some problem exploration, enhanced conceptual understanding, and to engage students as active participants in the learning process.

Student Learning Outcomes

Core Objectives: This course addresses the core objectives of critical thinking, communication, and empirical and quantitative skills.

Core Objective 1: Critical Thinking

Students will be able to analyze, evaluate, or solve problems when given a set of circumstances, data, texts, or art.

Core Objective 2: Communication Skills

In written, oral, and/or visual communication, A&M-Commerce students will communicate in a manner appropriate to the audience and occasion, with an evident message and organizational structure.

Core Objective 3: Empirical and Quantitative Skills

Students will be able to interpret, test, and demonstrate principles revealed in empirical data and/or observable facts.

Online Homework Assignments – Homework will be assigned daily through Cengage Webassign. Please check Cengage daily and work thorough homework assignments. **It is extremely important for you to work all homework in order to be prepared for the exams. In general, late work will not be accepted without appropriate documentation of a University-accepted absence.** A missed homework assignment or two, due to legitimate absence, will not significantly adversely affect your grade as long as you have kept up with all other assignments. Homework is due one week after the day it is assigned (or before the exam day, whichever comes first). Please do not wait until the due date to complete your homework to avoid emergency situations or run into technical difficulties. Loss of internet or a broken computer the night an assignment is due will not result in an extension of the deadline.

If a student experiences any technical difficulties with WebAssign, be sure to use the online help and technical support from the software company. If a student continues to have trouble accessing or navigating the software, please contact instructor through for some individual help.

Attendance: Attendance will be taken at the beginning each class. Logging into D2L and completing assignments and daily work will also be used to determine part of your attendance. Students need to actively participate in class and/or online to receive credit. Attendance and participation (in person and/or online) are a must to be able to do well in this class. Suggested Problems: There will be suggested problems assigned for each section. The answers to most of these problems are in the text, so I will not collect them. However, you will see some of these problem variations on tests!

The key to success

Workload and Assistance: The “rule of thumb” for a math class is that for every hour of class time, you should spend approximately 3 hours of study time outside of the classroom. This study time may include a variety of activities, including but not limited to: re-organizing notes; working on homework; participating in a study group, tutoring, workshops, or Supplemental Instruction session; attending review sessions; and studying for quizzes and exams.
