Course Information

This course covers the essential aspects of logistics management, focusing on the strategic coordination of goods, services, and information within the supply chain to satisfy customer demands. Students will examine key factors and challenges in the field, and practice designing and managing logistics networks that would deliver the Right product, in the Right quantity, in the Right condition, at the Right place, at the Right time, to the Right customer, at the Right price (Seven Rs).
