Course Description

This course provides coverage of a broad survey of global business issues; analyzes the environment in which international business operates; introduces multinational enterprises; global competition, international organizations, treaties and international laws, national trade policies, and the determinants of competitiveness of United States firms in international markets.

Assessments

Quizzes: 20% There will be one syllabus quiz and three chapter quizzes each worth 5% of your grade.

Exams: 24% There will be four timed exams each worth 8% of your grade. The best three exam grades of the four exams will be used and calculated in overall scores.

Discussion Board: 20% There are five discussion boards each worth 4% of your grade. Discussion board topics require a minimum of one post and two replies to fellow students. Discussions may be completed and submitted prior to the posted due date, but keep in mind that you will be graded on quality of content. Spelling, punctuation, capitalization, and grammar errors will have a negative impact on your discussion grades.

Case Study: 36% There will be four case studies each worth 9% of your grade. Students will be required to think critically about real life business issues. Please see the instructions in eCollege for more details.

IMPORTANT: Assignments may be submitted early, but I will count off one letter grade for each day an assignment is late. Exams, quizzes, and discussions will not be opened after the due date. No extra credit work will be assigned under any circumstances. The following are the ONLY acceptable excuses for missed assignments. CID Policy on Academic Integrity

- If the student does NOT have a previous Written Warning for academic dishonesty reported in CID courses and has additional attempts available for the assignment, the student may resubmit the assignment (this applies to CBE courses only).
- If the student has a Written Warning of academic dishonesty reported in CID courses, the student may NOT resubmit the assignment, and the instructor will follow the procedure detailed in [Policy 13.99.99.R0.03](#) for Undergraduate Academic Dishonesty and report the incident to the Provost Office.
