Course Description (2 semester credit hours)

This course focuses on social, economic, political, cultural, ethicolegal, and historical factors affecting nursing. It provides a forum for exploration of issues and concerns, enabling the critical analysis and evaluation of their effect on advanced practice nursing.

Student Learning Outcomes

Upon completion of the course, the student will have been given the opportunity to:

1. Use a systematic process to explore current nursing issues (AACN Essentials Domains 2 & 4).

2. Critically evaluate the social, economic, cultural, political, and historical influences on advanced practice nursing (AACN Essentials Domains 1 & 3).
3. Formulate opinions and beliefs about current nursing issues through the synthesis of current literature and research (AACN Essentials Domains 4 & 10).
4. Demonstrate the ability to support ideas in an organized, logical, and authoritative manner (AACN Essential Domain 4).
5. Analyze the use of political processes to create change in nursing (AACN Essential Domain 3).

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Using the learning management system, and using Microsoft Word, Microsoft Excel and PowerPoint.

Instructional Methods

This is an online course requiring students to complete reading assignments, online activities and independent study to be successful. Course objectives will be met through individual study using suggested resources, active involvement in classroom activities, formal, and informal exchange of ideas with classmates and colleagues regarding specific topics as well as utilizing critical thinking skills. Teaching methods include lecture, seminar, discussion, small group work, independent study of texts and library resources, computer-assisted instruction, audio-visual aids, and assignments. While the professor will provide guidance and consultation, the student is responsible for identification of learning needs, self-direction, seeking consultation, and demonstration of course objectives.

Student Responsibilities or Tips for Success in the Course

- Logging into the course website daily during the week
- **Checking emails at least daily, except Sunday**
- Updating semester calendar with communicated changes
- At least two hours of weekly study
- Attendance at all class meetings, clinicals, seminars and simulations
- Review of examinations.

Successful completion of the assignments will enable the student to meet the student learning outcomes.

Late Submissions:

It is expected that you will submit all class and clinical assignments on time. If you need an extension, it should be requested before the due date/time and may or may not be approved at the discretion of the course coordinator. Unexcused late assignments will be penalized 10% per day for each of the first two days overdue; on the 3rd day, the grade will be assigned as 0%. Communication on these matters is the student's responsibility. Multiple instances of late clinical assignments will result in receipt of a Student Performance and Behaviors Evaluation Form and, possibly, failure of clinical/course.

Paper Submissions:

All documents submitted online are to be in .docx, .rtf, or .pdf format. No other formats will be accepted (JPEG, GIF, etc.). Assignments need to be submitted in a maximum of one document per assignment. Failure to follow these guidelines will result in a grade of "0" on the assignment.

Submitting assignments: Upload all completed assignments to the appropriate area in D2L. Before uploading any assignment, name the file with the course number, your name, last, first, the assignment or document name submitted. Preceptor agreements for example would be- 5622 Callicoat, Donna, Preceptor Agreement Hanko.

Group Work:

All members of the group will receive the same grade on any group work.
However, a student can be removed from his/her team if the other students

in the group come to the instructor and report that a student is not doing his/her fair share of the work. If that happens, the instructor will notify the student in writing. The student will then be responsible for doing the assignment on his/her own. It is expected that the group will make the attempt to resolve the situation within the group before instructor intervention.

Assessments

Short Papers (4) 40% (10% each)

Students are expected to read the assigned article and identify strengths and weaknesses noted. Students will develop a response to the article, which will include references to support ideas. Paper should be substantive and supported by assigned readings, other resources, and/or professional experience (Learning Outcomes #1-5).

Issues Presentation 30%

Students are to develop a scholarly presentation on a selected topic of interest from the following list: Various APRN Roles; Changing Education; Changing Practice; Health Care Systems and Practice; Professional Challenges, Collaboration and Conflict. The instructor must approve the topic. Follow the grading rubric provided (Learning Outcomes #1-5).

Issues Paper 30%

Students are to develop a scholarly paper on a selected topic of interest from the following list: Cultural Inclusiveness; Legal, Ethical, and Social Issues; APRN's Role in Violence Prevention and Care; Global Nursing Considerations. The instructor must approve the topic. Follow the grading rubric provided (Learning Outcomes #1-5).
