## **Course Description**

This course prepares students for success with the Texas Essential Knowledge and Skills for Math. This course takes a closer look at how children learn mathematics, and how we can foster a mindset for doing mathematics. It includes: NCTM's principles for mathematics education; ways children develop mathematical understanding, problem solving skills, and processes used to get there; analyzing student's error patterns; and resources for teaching mathematics.

### **Student Learning Outcomes**

1. Evaluate and revise lesson plans based on NCTM standards, principles, and practices.
2. Examine challenges within mathematics programs in classrooms and schools.
3. Review existing literature regarding issues in mathematics learning and teaching.
4. Develop plans of action to implement change in mathematics learning and teaching.

### **Instructional Methods**

This fully online course will include various readings, activities, discussions, and assessments. Students will have the opportunity to interact with peers through online discussions and complete independent activities. Feedback will be provided throughout the course.
