Course Description

This course will introduce you to the basic foundations of ethics, overview of ethics in various professional fields such as psychology, counseling, social work, nursing, etc . Furthermore, this course will also introduce you to hot debates in professional field (e.g., should a self-driving car kill its passengers? The right to forget, Amazon Alexa HIPAA compliant).

This course is condensed into a short time-frame. An entire semester course will be presented in 8 weeks. Be prepared to do a large quantity of work in a short duration.

Student Learning Outcomes (SLO)

1. Develop an overview of the basic foundations of ethics.
2. Learn to apply the principles of ethics in various professional settings.

3. Learn to critique and see the inadequacy of the principles of ethics.
4. Develop an overview of ethics in professional settings highlighted in this course.
5. Learn to apply the principles of ethics in emerging fields and propose ethical guidelines.

COURSE REQUIREMENTS

Instructional Methods

This is an online course. You will be expected to follow the video lectures, read assigned materials, take notes and review portions of lectures. You will also be expected to read the assigned materials, do the necessary research and complete the assignment. You are encouraged to discuss with your classmates or anyone who has knowledge or insights on the topic. However, you are expected to take others’ input, assimilate them and compose your own work.

Student Responsibilities or Tips for Success in the Course

- Check and read class emails promptly for announcements, updates, clarifications, etc.
- Take notes while you read the assigned materials and listen to lectures. When we travel, we take our own pictures to organize our experience instead of downloading pictures online later. Similarly when we learn, we take our own notes to organize our thoughts.
- Quiz yourself often. Can you define a concept in your own words? Study the materials on a regular basis. Consider the Pomodoro technique. Set aside 20-25 minutes each time, and study.

- Take the initiative and read a few most recent research articles on the topics we discuss in our class.
- Learn and discuss **collaboratively**, however, compose and complete your assignments **independently**.

Assessments

Learning Engagement: This class will employ active learning techniques. *Primarily SLO1, 2, and 4* will be assessed. Students' engagement will be assessed based on the following criteria: 1) timely completion of video lectures and assigned learning materials; and 2) successful completion of learning engagement quiz or activities assigned. The learning engagement quiz will test if you attend to the contents of video lectures and assigned learning materials.

Learning Engagement Total: 100 points

Assignment and Discussion: *The questions align with each of the 5 learning outcomes, in particular, SLO 2, 3, 4, and 5.* We typically will provide case study and ask students to work toward SLO 2, 3, 4, and 5.

If for some REAL emergency you must delay your submission, make sure that you contact me immediately. When official documentation is provided, you can do a make-up.

You are encouraged to voice your ideas, however, you are expected to respect everyone in class. *Disruptive behavior or disrespect* toward other students or the instructor will not be tolerated. At the very least, it will cost a letter grade, and is subject to further penalty.
