Course Description

Course Catalog HHPS 210: An overview of the principles of psychology as applied to sport, exercise, and recreational activity for enhanced interactions and performance. This course will examine elements of sport psychology such as anxiety, self-confidence, motivation and goal setting, leadership, and group dynamics with sport and recreational activities.

This course examines psychological theories and research related to sport and exercise behavior. The course is designed to introduce you to the field of sport and exercise psychology by providing a broad overview of the major topics in the area. The course objectives are as follows:

- _To increase your understanding of how psychological factors influence involvement and performance in sport, exercise, and physical education settings
- _To increase your understanding of how participation in sport, exercise, and physical education influences the psychological makeup of the individuals involved
- _To help you acquire skills and knowledge about sport and exercise psychology that you can apply as a coach, teacher, athletic trainer, or exercise leader
- _Describe the field and history of sport psychology
- _Discuss the theoretical foundations of the psychological processes that operate in a variety of sport settings.
- _Recognize the processes of learning, anxiety, and performance enhancement.
- _Discover how participation in sport influences the psychological makeup of the individual involved.
- _Apply motivational principles to “real world” settings.
- _Identify the psychological processes for both individual and group processes.

As a rule of thumb, one cites whenever they are paraphrasing other people's words or when they quote other's words directly. You may learn to cite from a variety of different sources including the APA Tutorial and the sources listed below and in the Getting Started section of your course.
