Course Embedded Objectives:

Upon satisfactory completion of this course, the student will:

- Develop specific skills, competencies, and points of view needed by professionals in accounting;

- Prepare and interpret budgets, cost-volume-profit analyses, and other managerial reports.

Teaching Procedures

CPA Exam Candidates - State of Texas

Candidates who desire to sit for the CPA in Texas must meet the following educational criteria:

- 1) Have a bachelor's degree
- 2) Completed 120 semester hours of courses
- 3) Included in the 120 semester hours, 24 hours of accounting with 21 upper level accounting courses
- 4) 3-semester credit hours of approved ethics ACCT 430 (*does not count towards upper level accounting courses*)
- 5) 2-semester credit hours of approved communication (ACCT 311 Financial Statement Analysis- Required & ACCT 421 Advanced Accounting- Elective) - one credit from each class
- 6) 2-semester credit hours of approved accounting research (ACCT 340 Income Tax- Required & ACCT 427 Auditing- Required) - one credit from each class

Concealed Carry

Texas Senate Bill - 11 (Government Code 411.2031, et al.) authorizes the carrying of a concealed handgun in Texas A&M University-Commerce buildings only by persons who have been issued and are in possession of a Texas License to Carry a Handgun.
