# **Course Information**

#### **Course Description**

Styles, forms, and composers from the pre-classic school to the death of Beethoven.

#### **Student Learning Outcomes**

In this course, students will become familiar with practices and issues related to music during the Classic period through exploration of topics such as institutions, music societies, patronage, and education.

#### Required Textbook

Rice, John. Music in the Eighteenth Century. New York: W.W. Norton, 2013.

# **Course Requirements**

#### Instructional Methods

Students will follow outlined activities for each week that include readings, in-person discussions, and assignments.

#### Assessments

Participation: This course is based on in-person discussion and not lectures. Students are expected to come to class prepared to discuss assigned readings and pieces.

Style Analysis: Students will complete a short analysis of JS Bach in the context of the Learned and Galant styles.

Response Essays: Students will write three response essays of 600-750 words that respond to assigned prompts. These essays require students to reflect on and engage critically with music and concepts discussed in class. Essay prompts and detailed instructions will be made available on D2L.
