# **Course Description**

This course is an introduction to syntactic theory as it is practiced broadly speaking in the standard Chomskian paradigm. The background and origins of Generative-Transformational grammar are examined, as well as the various theoretical contribution that have been integrated in the theory. Some applications to philosophical, psychological, and pedagogical issues are also discussed.

## **Student Learning Outcomes**

- 1. The students will demonstrate knowledge of syntactic theory, its history, and development.
- 2. The students will demonstrate knowledge of immediate constituent analysis.
- 3. The students will produce syntactic trees displaying the structure of a sentence.
- 4. The students will demonstrate knowledge of the internal organization of syntactic theory.

## Instructional Methods

You must have read the relevant chapter in the book by the day of the lecture.

b) watch the video of the lecture on the LMS (usually uploaded during the night).

You MUST either attend or watch the video of the lecture. Of course you can do both. Failure attend or watch the lecture will result in failure on the quizzes.

You must post 2 contributions to the week's Q&A. You may post questions about the lecture/contents of the book or answer other students questions. Obviously you may post more than 2 Q&A, if you want. The Q&A period opens Monday at 0:01 AM CST and closes Thursday at 11:30 pm CST. You cannot post in the Q&A after that time.

You then must take the weekly CR (comprehension review). The CR opens Friday at 0:01 am CST and closes Sunday at 11:30 pm.

#### There will be no extra credit.
