This course introduces the major theories of first and second language acquisition.

Because this is a summer semester (10 weeks) the class requires weekly work and assignments.

2. Students will be able to describe the theories of second language acquisition.
3. Students will be able to draw comparisons and analyze differences between the two.

University AI use in course policy

Texas A&M University-Commerce acknowledges that there are legitimate uses of Artificial Intelligence, ChatBots, or other software that has the capacity to generate text, or suggest replacements for text beyond individual words, as determined by the instructor of the course.

Any use of such software must be documented. Any undocumented use of such software constitutes an instance of academic dishonesty (plagiarism).

Individual instructors may disallow entirely the use of such software for individual assignments or for the entire course. Students should be aware of such requirements and follow their instructors' guidelines. If no instructions are provided the student should assume that the use of such software is disallowed.

In any case, students are fully responsible for the content of any assignment they submit, regardless of whether they used an AI, in any way. This specifically includes cases in which the AI plagiarized another text or misrepresented sources.

In light of the above procedure, any use of Ai software in this class is not allowed.

You will probably have heard about ChatGPT4, an artificially “intelligent” chat bot with some remarkable capacities in generating natural sounding text. You may be tempted to use it to help you answer questions in the quizzes or to help with your project. Here are a few reasons not to do it:

I tested ChatGPT4 and while its performance is impressive it is not always accurate. ChatGPT4 make mistakes. If you use ChatGPT4 those mistakes become your mistakes.

You have to disclose the use of ChatGPT4. If you do not disclose it you are guilty of plagiarism, which carries serious consequences, up to being expelled from the university.

The purpose of the quizzes is to prepare you for the final exam. The final exam is a viva voce (oral) exam in which the instructor will ask you questions and you will need to answer. It is impossible to use ChatGPT4 during the viva. Hence, if you have not studied the material you will fail the final exam.

The terminology and definitions used by ChatGPT4 may differ from those used in this class. The instructor is not responsible for explaining those differences to you (much like if you choose to use a different textbook the instructor is not responsible for explaining the other textbook to you). For example, ChatGPT4 defined on one occasion a prepositional phrase as an adverbial phrase, which would be counted as a mistake in this class, but might be acceptable terminology under other systems.
