## COURSE INFORMATION

#### **Materials**

**Textbook(s) Required:** Calculus, 9th Edition, by James Stewart. ISBN-13: 978-1337624183. Parts or all of the chapters 5 through 8 and chapter 11 will be covered. We may occasionally cover enrichment activities, not in the text.

**Course Description:** This course examines the integral calculus of functions of one variable and some integral calculus of functions of two variables, as follows. Topics include techniques of integration, applications of the integral; improper integrals; limits involving indeterminate forms; sequences and series; and use of computer technology. The prerequisite for the course is Math 2413 (Calculus I).

The use of a graphing calculator having at least the capabilities of the TI-83 will be helpful throughout the course. TI-89 is highly recommended. A computer algebra system will be used for some problem exploration, enhanced conceptual understanding, and to engage students as active participants in the learning process.

## **Student Learning Outcomes**

**Core Objectives:** This course addresses the core objectives of critical thinking, communication, and empirical and quantitative skills.

## Core Objective 1: Critical Thinking

Students will be able to analyze, evaluate, or solve problems when given a set of circumstances, data, texts, or art.

## Core Objective 2: Communication Skills

In written, oral, and/or visual communication, A&M-Commerce students will communicate in a manner appropriate to the audience and occasion, with an evident message and organizational structure.

## Core Objective 3: Empirical and Quantitative Skills

Students will be able to interpret, test, and demonstrate principles revealed in empirical data and/or observable facts.

# **COURSE REQUIREMENTS**

**Instructional Methods:** Video Lectures will be provided under D2L, created by the professor, demonstration and models, and some group work, based on time available.

#### **Course Evaluation Methods**

This course will utilize the following instruments to determine student grades and proficiency of the learning outcomes for the course.

**Exams** – There will be two Mid-term exams and a Comprehensive Final Exam. Each exam will be proctored through ZOOM. The ZOOM link to the Virtual Exam room will be provided in advance. To take the exams, you need to have a webcam and a microphone both in working conditions.

**Quizzes** –There will be no make-ups for any missed quizzes. Instead, at the end of the semester, only the highest seven quizzes will be considered.

**Each week, two quizzes** will be posted on the course home page under D2L: **One** on Tuesday at 8 am due to next day Wednesday 9 am and **the other** quiz on Thursday at 8 am due to next day Friday 9 am.

The student will download the posted quiz questions, write his/her answers/solutions on a separate sheet with the academic integrity statement on the top ("On my honor, as a student, I have neither given nor received unauthorized aid on this academic work," and sign under that statement), scan the sheet(s) and submit the scanned pdf file to the virtual basket under D2L (Activities Assignments Quiz #) as

- **Online Homework Assignments** (from WebAssign): There is an online supplement to your textbook called WebAssign. There will be an online homework assignment in WebAssign for each section covered in the course. You will have an unlimited number of attempts to complete an assignment by the due date given, and your highest grade will be recorded. You will see variations of these problems on tests, so completing the online homework problems is strongly encouraged! The Class Key is going to be provided on the first day of the class under D2L.
- **Attendance:** Online attendance is required. It is critical that you keep up with the pace of this class. A term goes quickly. Once you are behind our pace, you can easily get lost. I strongly suggest you study ahead of our pace continuously review the material. Online attendance in this course is determined by your log-in and participation in our course in D2L.

Attendance means students will watch posted videos, join online discussions, and submit required assignments on time.

- **Suggested Problems:** There will be suggested problems assigned for each section. The answers to most of these problems are in the text, so I will not collect them. However, you will see some of these problem variations on tests!
- **The key to success** in this course is regularly working with other students in the class, doing the homework early, and asking questions when you have them. We will discuss homework problems in class, but there will often not be enough time to discuss all of them. Please come to office hours or visit the math tutoring lab if you have additional questions about the homework.
- **Workload and Assistance:** You should expect to spend 3 to 5 hours each day, outside of class, on the course material. This includes watching the posted videos, reading, homework, and studying for quizzes and exams. Some weeks (those in which an exam is scheduled, for instance) may require more of your time, and other weeks may require less. In addition, you should spend some time working with other classmates on Discussions or Virtual Office under D2L! Please ask questions and seek assistance as needed. You should use my

Virtual Office hours, or you may email me at any time. Emails are answered usually within 24 hours during weekdays (M-F).

## **GRADING**

**Grading Matrix:** This class will be graded on a total points system. 400 points are the maximum possible points in the class. - TI-83/84 or other calculators with similar capability is recommended.
