**COURSE INFORMATION**

This course has been designed using Open Educational Resources (OER) and/or materials that are available through the internet or Waters Library. All materials are embedded within the course or are accessible via the internet or accessible through the Waters Library resource portal.

**Course Description**

This course explores the first and second language acquisition and development of children from birth to sixth grade. Students will examine the components of oral, written, and academic language that benefit from and promote early literacy development. Special emphasis is given to the teacher's role in supporting language development, in planning developmentally and culturally appropriate learning experiences, and in partnering with parents to foster language and early literacy development. This course will address essential topics such as phonological awareness, authentic language assessment, data-driven instruction and intervention, concepts of print, emergent writing development, and the alphabetic principle.

**Student Learning Outcomes** (Should be measurable; observable; use action verbs)

1. Apply knowledge of language acquisition and literacy development to design an infographic depicting balanced literacy instruction aligned to the context for learning to reflect developmentally appropriate practices.
2. Integrate pedagogical knowledge to state learning standards to formulate an “ABCD” learning objective that includes listening and speaking skills with linguistically accommodating instructional sequences aligned to proficiency-level descriptors for ELLs.
3. Implement data-driven instructional practices to promote language acquisition and literacy skills by creating a developmentally appropriate assessment plan that synthesizes pedagogical knowledge with context for learning and the learning objective.
4. Synthesize pedagogical knowledge, context for learning, learning objective, and assessment plan to design a developmentally appropriate, culturally relevant interactive read-aloud lesson plan.
5. Promote family engagement in children’s language acquisition and literacy development by transforming the interactive read-aloud into an oral retelling fostering a developmentally appropriate and meaningful language experience.
