## Assessments

1. Students should work a *minimum* of 9-12 hours per week in completing course assignments. I encourage you to read approximately 20-30 pages per day of assigned readings to complete all requirements in a manageable manner.
2. The course calendar (which includes due dates for assignments) is at the end of this syllabus.
3. For the graded postings for Forums 1, 2, and 3 do the following:
  - Acquire a legal case mentioned in the assigned reading (*choose one that you think might be interesting; i.e., one that you want to read!*);
  - Read the case; and

- Write a 250-word posting that discusses a major legal principle from the case and how this principle informs higher education administration. Do not focus exclusively on presenting the details of the case itself; the major purpose of this assignment is to use a major legal principle from a case to form an administrative principle.

The grading rubric for this posting will be 60% content and 40% writing (includes grammar and APA usage). Note that “APA usage” refers to proper in-text citations as well as the format for end-of-posting citations. No other APA requirements are necessary other than those also associated with grammar. I will email each student individual feedback via the D2L portal to your TAMUC email account; thus, please notify me if you do not receive any feedback. Please carefully review my edits and comments in the documents I email you (use the All Markup feature in Word to review them) and learn from my feedback; that is, do not repeat any errors in your future postings.

You are strongly encouraged to respond to your colleagues’ postings. Although ungraded, your responses will facilitate learning via discussion and build a sense of community.

4. For the graded Scenario Analysis you will respond to the instructor’s posted prompt with a 100-word posting (and I truly want a focused posting of approximately 100 words). The grading rubric for this posting will be 60% content and 40% writing (includes grammar and APA usage). Note that “APA usage” refers to proper in-text citations as well as the format for end-of-posting citations. No other APA requirements are necessary. These will be done in the assignment section of D2L.
5. The examination is an open book, open notes, open web assignment and is an individual activity (i.e., working with others will be a violation of academic integrity). You may email the instructor requesting further clarification for specific examination items who may post a response to the entire class in order to help everyone. The instructor will supply the examination at the beginning of Period 13 as an attachment in a D2L course announcement. Do not distribute the examination to anyone outside of this course as it may be reused in future courses; distribution will be a violation of academic integrity. **The completed examination must be emailed to the instructor by the due date/time.**
