Instructional Methods

This will be primarily a lecture & readings course. The lecture & readings will provide all the evidence you need for creating evidence-based answers to the essay questions on the exams & for the reading quizzes. The exams are scheduled for in class, and you will have the entire class period to finish writing your answer.

Student Responsibilities or Tips for Success in the Course

It is in your best interest to do the readings in advance. Lectures are built around <u>Yawp</u> chapters and will fill in detail that may not be in the lectures. Come to class for the required assignments. Make-ups must be scheduled either the week before or the week after the assignment has been completed in class.

Assignments:

Exams: This course will have two, one-question essay exams written during allotted class times. These exams will take the entire class period to complete. You will write a clear, coherent, and structured essay. We will go over the rubric in class before the first exam. (SLO 1,2,4)

Quizzes: There will be short, five question reading quizzes in class over the readings for the week. These will usually be on Thursdays. The lowest will be dropped. (SLO 1,3) **Short IDs:** These three assignments will ask you to identify and describe the prompt. We will go over the rubric in class, the lowest will be dropped. (SLO 1,2,4) **Participation:** It is in your best interest to attend lectures. This grade will be a combination of attendance and participation. (SLO 2)

Note on handwriting & spelling:

Do not fret about whether I can read your handwriting, if there is a serious problem I will ask you about it. Otherwise, assume that I can read your writing just fine. Further, since most of your assignments are written in-class, I will not count spelling errors against you. I am not grading your English; I am grading your knowledge of course material.

Interaction with Instructor Statement

If you need to reach me outside of normally scheduled office hours, please use email. I typically respond to email within 24 to 48 hours during the week. Do not expect a response during the weekend.

When sending an email always do the following:

- 1) Use a subject line. This tells me what the topic is and prevents your message from ending up in my junk mail.
- 2) Include your class and section. I need to know exactly which of my courses you are in before I can help you.
- 3) End the email with your name, that is "sign" your message. I also need to know who you are.

Course Specific Procedures/Policies

Academic Honesty and Dishonesty

You are expected to do your own work. Dishonesty will not be treated lightly. On each graded assignment I expect each student to honor the following pledge: "I hereby give my word that I have neither given nor received aid while completing this assignment."

Any student found violating this policy will receive a grade of zero for the assignment, and further action may be taken.

Plagiarism:

Plagiarism is taking someone else's work and passing it off as your own words, thoughts, or ideas. This includes, but is not limited to, using direct quotes out of a book or from the internet as your own words, properly using quotation marks but noting the wrong person as the author, purchasing a paper or exam from friends or strangers, using material from the internet verbatim as your own words, and cutting and pasting entire papers or internet pages and passing it off as your own work. Cheating on exams and discussion posts or allowing others to copy your answers is another form of academic dishonesty. It may be acceptable to use other people's words as short quotations and ideas as long as they receive credit in citations. If you are unsure about the precise definition of plagiarism and/or think you may have committed this form of academic dishonesty, see the instructor or visit the Online Writing Lab before you turn in the assignment.

AI: From the University,

Texas A&M University-Commerce acknowledges that there are legitimate uses of Artificial Intelligence, ChatBots, or other software that has the capacity to generate text, or suggest replacements for text beyond individual words, as determined by the instructor of the course. Any use of such software must be documented. Any undocumented use of such software constitutes an instance of academic dishonesty (plagiarism). Individual instructors may disallow entirely the use of such software for individual assignments or for the entire course. Students should be aware of such requirements and follow their instructors' guidelines. If no instructions are provided the student should assume that the use of such software is disallowed. In any case, students are fully responsible for the content of any assignment they submit, regardless of whether they used an AI, in any way. This specifically includes cases in which the AI plagiarized another text or misrepresented sources.

I do not usually give extra credit. Do not ask; that will lower the possibility further.

Note on Electronics:

Using your laptop for notes is acceptable, though I do advise hand-written notes for no other reason than they help you remember things. My only non-negotiable is: do not use your smartphones in class. There may be times where I ask the class to look something up, but otherwise, do not use them. Preferably your smartphones will stay silent in your backpack or pocket for the duration of class. These classes are only fifty minutes, you

can do without it for that time. Further, it is a distraction for both myself as the instructor and your fellow students.

Excessive use will ensure that you will not be counted as present on the day's attendance. It is not only rude to be on your phone during lecture, but also cuts from time you paid for.
