### **Course Description**

A theoretical approach to multiple social issues with emphases on minorities and sport, women and sport, youth and sport, religion and sport, deviance, and sport, as well as other current social issues affection the sport industry today, as well as future trends. The course will include an examination of social and ethical issues which affect sport, the sport industry, and sport managers in today's global marketplace. Topics will also include a survey of the cultural, economic, and technological structures which compose, and contribute to, an ever-changing and expanding international sport business. This course will analyze sport organizations, and the production and consumption of sport products, which shape global sport commerce.

### **Course Objectives**

At the end of this course the students will be able to:

1. Describe sociological theories and their relation to the historical underpinnings of sport
2. Understand the importance and influence of sport on individuals, groups, and society
3. Understand regional, national, and international sport cultures
4. Appreciate the complexity of international sport governing bodies, events, and traditions
5. Discuss various social issues within the global marketplace and in the context of sport
6. Demonstrate knowledge of the interconnectedness of global dynamics and apply that knowledge as an engaged citizen within an interconnected and diverse world

## Assignments

### 1. Social Issue Presentation (200 points)

Students will be tasked with creating a social issue project to highlight a sport-related social issue of their choosing. A specific rubric and project template will be provided to students in our D2L course. This project will be due in Week 15.

Sample topics may include (but are not limited to the following examples):

- a) Women in sport
- b) Mega event hosting bids
- c) Corruption in global organizations in sport
- d) Race and sport
- e) Doping in sport
- f) Sexuality in sport
- g) Paralympic sport

### 2. Weekly Participation (150 points)

Each week students will be given a movie/video/reading to review for weekly participation. Instructions and rubric for each week will be provided in our D2L class.

### 3. Weekly Quizzes (150 points)

Weekly quizzes will be used to assess student conceptualization of the material presented each week.

#### **4. Exams (500 points total):**

There will be 3 exams administered throughout the semester. Exam 1 will be given in Week 4, Exam 2 will be given in Week 8, and Exam 3 (Final Exam) will be given in Week 16. Exams 1 & 2 are weighted at 150 points each with Exam 3 weighted at 200 points.
