#### **Course Description**

An examination of the management and operational techniques and strategies for sport and recreation programs. Topics include an in-depth look at strategic management and governance of international sporting organizations and other organizations in the sport and recreation industry (which may include NCAA Division II Intercollegiate athletics, Campus Recreation, City Parks and Recreation), managing people in sport organizations, as well as the determination of strategic direction for sport and recreation organizations and effective implementation of strategies.

#### **Course Objectives**

At the end of this course the students will be able to:

The functions of planning and organizing are an integral part of the course, as well as managing budgets, political challenges, staffing, strategic planning, emotional intelligence and diversity.

Culture and a better understanding of complex problem solving in a very fast paced and ever changing climate in the sport and recreation field.

Go beyond book and classroom knowledge and transition into the actual practice of sport and recreation management.

Demonstrate knowledge of the interconnectedness of global dynamics and apply that knowledge as an engaged citizen within an interconnected and diverse world.
