Course Description

Course Description:

The purpose of this course is to examine the social institution of sport, and its consequences for American society. Throughout the course we will discuss and examine topics such as the social organization of sport from play to professional sport, deviance and violence in sport, sport and other societal institutions, the influence of sport on different social groups, and the socialization implications from participation, and spectatorship, in sport.

- 1. Discuss sociological theories and their relation to sport.
- 2. Understand the importance and influence of sport on individuals and groups.
- 3. Discuss different social issues within society and in the context of sport.
- 4. Demonstrate critical thinking skills in class activities, assignments, and discussions.
- 5. Demonstrate the ability to write in accordance with the guidelines set forth by the American Psychological Association (7th ed.).
