### **Course Description**

Methods of inquiry and analysis to evaluate the effectiveness of training, development, and performance improvement programs. Topics include various evaluation models, ways to assess satisfaction, learning, behavioral changes, and impacts, and how to integrate evaluation with planning or continuous improvements.

- Assess and improve evaluator's readiness and competence.
- Identify, organize, and engage the primary audience.
- Analyze the situation jointly together with the primary audience.
- Identify and prioritize intended uses.
- Consider and build in processes.
- Creative effective questions related to implementation, outcomes, and attribution.
- Determine an appropriate intervention or change model.
- Negotiate appropriate methods and generate findings matching intended uses.
- Educate users about potential issues and controversies commonly arise.
- Gather, organize, and present relevant data.
- Prepare and disseminate reports, and follow up, all to drive further use.

## COURSE REQUIREMENTS

### Instructional Methods

This is a fully online course. Assignments will be delivered via the D2L learning media platform. Knowledge of the substantive material covered in the course is of central importance. Grading will include consideration of content as well as grammar, spelling, organization, and explicit use of readings. A serious commitment to mastery of the content and contribution to everyone's learning is expected. An online course inherently requires students to be active, reflective, and contributive learners.

Assigned readings are noted within the module overview as well as on the course schedule. Required module readings will serve as a basis for online discussion. Late submissions, one week past the due date **WILL NOT** be accepted, and **each day late will incur 10% score deduction**. I do understand that sometimes there are circumstances outside one's control that may impact timely submission of assignments, such as jury duty, hospitalization, or death of a family member. In these instances, a student is expected to notify the instructor **BEFORE** the assignment deadline.

### GRADING

#### **Discussion Boards (6 at 20 points each = 120 points total):**

Each discussion thread topic will require a "post" and two "replies" to fellow classmate's posts.

**Initial Post (80%):** Module discussion is to verify your understanding of readings and applying learning to your own work. You will not be able to read other's post until you post your own work. Students will need to complete an initial "post" to each discussion

board thread at least four days before the module end date. Review “post” content for correct grammar and spelling.

**Replies (20%):** The sharing of feedback with your classmates is expected to strengthen the application of module learning to your (dissertation) research. Review “reply” content for correct grammar and spelling. It is suggested that each reply consist of a minimum of four to five complete sentences.

**Cumulative Project (50 points):**

The major paper/project for the class is a program evaluation report that will be a synthesis and application of the book content as it applies to organizational or program settings. More details can be found in the course shell.
